**SCHEDULING PUBLIC HEARINGS FOR DELEGATE AGENCIES FUNDED THROUGH THE FY 2015 AND FY 2016 CONSOLIDATED FUNDING PROCESS FOR HUMAN AND WORKFORCE DEVELOPMENT SERVICES FOR TUESDAY, AUGUST 19, 2014 AND TUESDAY, AUGUST 26, 2014.**

**WHEREAS**, on March 10, 2014, the Department of Human Services released a Request for Proposals for Consolidated Human and Workforce Development Services for FY 2015 and FY 2016; and

**WHEREAS**, at the recommendation of the City Council, the City will hold two Public Hearings on August 19, 2014 and August 26, 2014, both to begin at 6:00 p.m. to provide respondents with an opportunity to advocate for their proposals; and

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**



**SECTION 2.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective the tenth day after passage.


