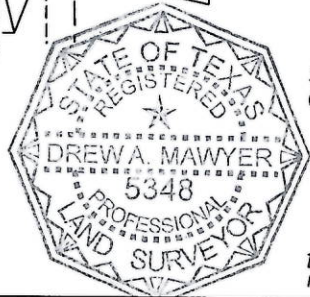

White Subdivision as recorded in Volume 9714, Page 75-76 of the Deed and Plat Records of Bexar County, Texas, and conveyed in Volume 17598, Page 1782 of the Official Public Records of Bexar County, Texas, and said 0.152 of an acre of land being more particularly described as follows:

BEGINNING at a 1/2" iron pin found for the Northeasterly corner of Lot A-41 as conveyed to Robert Gomez in Volume 10105, Page 1858 of the Deed Records of Bexar County, Texas, and being an interior corner of said Lot 81;

THENCE with a Southerly line of Lot 81, the Northerly lines of said Lot A-41, S 89° 48' 42" W a distance of 11.35 feet to a point for the Southwesterly corner of this herein described 0.152 of an acre tract of land;

THENCE across and through said Lot 81, N 02° 25' 27" W a distance of 440.62 feet to a point in the Southerly line of a 100 foot drain Right-Of-Way as recorded in Volume 4873, Page 587-589 of the Deed Records of Bexar county, Texas, and being in the Northerly line of said Lot 81;

THENCE with the Northerly line of said Lot 81, N 89° 49' 52" E a distance of 15.01 feet to a point for the Northeasterly corner of this herein described 0.152 of an acre tract of land;


THENCE departing the Northerly line of said Lot 81, and across and through said Lot 81, the following calls:
