## AUTHORIZING AN AMENDMENT TO THE AGREEMENT FOR THE USE OF PUBLIC RIGHT OF WAY IN SUPPORT OF THE HERTZ CARSHARE PROGRAM,

WHEREAS, the City has previously entered into a Hertz On-Demand Carshare Agreement ("Contract") with The Hertz Corporation d/b/a Hertz on Demand under the authority of Ordinance 2012-03-29-0210.

WHEREAS, the parties have agreed, subject to council approval, to add to the number of on-street parking spaces dedicated to the Hertz Carshare program, and the Council finds the amendment to be in the best interests of the City.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee, severally, are authorized and directed to execute and deliver on behalf of the City an amendment to the Contract in form satisfactory to the City Attorney including the on-street spaces described in Attachment I, which is incorporated for all purposes as if fully set forth, among those potentially allocated to the Contract. The amendment authorized hereby should add the spaces to Exhibit B of the Contract.. The City Manager and her designee, severally, should take all other actions necessary or convenient to effectuate the transaction, including agreeing to non-material changes to the approved form.

SECTION 2. Funds generated by this ordinance will be deposited into Fund 53001000, Internal Order 219000000128 and General Ledger 4403145.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance becomes effective 10 days after signature, unless it receives the eight votes requisite to immediate effectiveness under City Code of San Antonio § 1-15, in which case it becomes effective immediately.
