

AN ORDINANCE 2015-10-29-0911

**AUTHORIZING AN AMENDMENT TO A CONTRACT WITH SILSBEE FORD TO PROVIDE 118 2016 FORD POLICE INTERCEPTOR UTILITY ALL WHEEL DRIVE REPLACEMENT VEHICLES FOR THE SAN ANTONIO POLICE DEPARTMENT FOR A TOTAL COST OF \$3,161,574.00 FOR THIS AMENDMENT, FUNDED FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND.**

**WHEREAS**, the City entered into a contract with Silsbee Ford on April 2, 2015 through Ordinance 2015-04-02-0207 for the purchase of 230 model year 2016 Police Interceptor Utility AWD vehicles for a cost of \$6,162,390.00 ("Original Contract"); and

**WHEREAS**, the contract allows the City to order additional vehicles through November 2015 under the same terms and conditions, including price; and

**WHEREAS**, this ordinance authorizes an amendment to the contract for the purchase of 118 additional 2016 Police Interceptor Utility AWD vehicles for an additional cost of \$3,161,574.00; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The Director of Finance, or his designee, is hereby authorized to execute an amendment to the Original Contract in the form attached hereto as **Exhibit I** for the purchase of 118 additional 2016 Police Interceptor Utility AWD vehicles for an amount not to exceed \$3,161,574.00.


**SECTION 2.** Funding for this ordinance in the amount of \$3,161,574.00 is available as part of the Fiscal Year 2016 budget in Fund 72001000, Cost Center 3503200001 and General Ledger 5501055. Payment not to exceed the budgeted amount is authorized to Silsbee Ford and should be encumbered with a purchase order.


**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.

The City of San Antonio and the vendor identified above hereby agree to amend the contract identified above, as follows. This amendment is authorized pursuant to the section entitled "Amendments" in 006, General Terms & Conditions of the above referenced contract, and Addendum three issued thereto.

1. AMENDMENT

Invitation For Bids (IFB) Document Section 004 - SPECIFICATIONS / SCOPE OF SERVICES and PRICE SCHEDULE are hereby revised to reflect an increased quantity of Item 1, Police Package SUV All Wheel Drive, increasing the quantity of the purchase by an additional 118 vehicles for a total of 348 vehicles. Pursuant to section 4.2.1 of the original contract as amended by Addendum III, prices shall remain the same as in the original contract.

The delivery schedule for the 118 additional vehicles will be as follows:

- 25 vehicles will be delivered in the month of March 2016
- 25 vehicles will be delivered in the month of April 2016
- 25 vehicles will be delivered in the month of May 2016
- 25 vehicles will be delivered in the month of June 2016
- 18 vehicles will be delivered in the month of July 2016

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.
