

ORDINANCE 2019-11-14-0956

**AWARDING A CONSTRUCTION CONTRACT TO ALAMO CITY  
CONSTRUCTORS, INC. IN AN AMOUNT NOT TO EXCEED \$470,411.20  
FOR THE GROWDEN GATE 3RD LANE PROJECT.**

**WHEREAS**, the Growden Gate 3<sup>rd</sup> Lane Project is a project being completed in partnership with Joint Base San Antonio (JBSA); and

**WHEREAS**, the City of San Antonio owns the Growden Gate right-of-way in front of the inspection area at JBSA and the Growden Gate commercial vehicle inspection lane's check point within the inspection area serves all commercial vehicles entering JBSA - Lackland Main Base; and

**WHEREAS**, the check point is currently undersized and inadequate to accommodate traffic at peak hours and the road leading to the check point is a two lane road which does not have a lane for vehicle stacking creating a risk for head-on collisions; and

**WHEREAS**, the Project will alleviate commercial vehicle traffic stacking on Growdon Road up to 1,000 feet beyond the commercial vehicle inspection lane entry area and will widen Growdon Road into three lanes to accommodate commercial traffic waiting to enter the vehicle inspection check point; and

**WHEREAS**, the Project will also mill and overlay and reconstruct the driveway to Growden Gate; and

**WHEREAS**, the City advertised the Growden Gate 3<sup>rd</sup> Lane Project in August 2019 and received two bids which were opened on October 1, 2019; and

**WHEREAS**, this Ordinance accepts the lowest responsive bid submitted by Alamo City Constructors, Inc. in an amount not to exceed \$470,411.20; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The lowest responsive bid submitted by Alamo City Constructors, Inc. in an amount not to exceed \$470,411.20 for the Growden Gate 3<sup>rd</sup> Lane Project, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates.

**SECTION 2.** Payment is authorized to be encumbered and made payable to Alamo City Constructors, Inc. in an amount not to exceed \$470,411.20. Payment is in support of the Growden Gate 3rd Lane Project, using Fund 40099000, WBS element 23-03752-05-02-01 and

GL account 5201140. Funding is provided by Certificates of Obligation and is budgeted as part of the FY2020 - FY2025 Capital Improvements Program.

Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.


**SECTION 4.** This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
