

AN ORDINANCE 2017-11-02-0847

**AUTHORIZING THE CITY OF SAN ANTONIO OFFICE OF EMERGENCY MANAGEMENT TO APPLY FOR, ACCEPT, AND APPROPRIATE UPON AWARD, \$28,850 FROM THE 2017 PREVENTATIVE RADIOLOGICAL AND NUCLEAR DETECTION GRANT PROGRAM.**

**WHEREAS**, the Office of the Governor (OOG), Homeland Security Grant Division (HSGD) has grant funds available to fund the 2017 Preventative Radiological and Nuclear Detection (PRND) Grant Program in the amount of \$28,850.00, to provide the City of San Antonio Office of Emergency Management (SAOEM) additional capability to detect radiological threats; and

**WHEREAS**, the SAOEM has been a participating member of the Texas Nuclear Sector Working Group since 2015; and

**WHEREAS**, during a recent workshop it was determined that large urban areas required additional or new radiological detectors; and

**WHEREAS**, the state created the PRND Grant Program using 2015 State Homeland Security Program grant funds to address this need; and

**WHEREAS**, no City matching funds are required; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee, or hereby authorized to submit a grant application, accept grant funds upon award in the amount of \$28,850.00 from the PRND Grant Program, and appropriate said funds to purchase the following radiological detection equipment: 1 BNC 945 GN RIID – Isotope Identifier with Reachback; 13 MiniRad - Personal Radiation Detectors (PRD); and, 5 Personal Radiation Detector (PRD) Response Checks. A copy of the application is on file with the San Antonio Office of Emergency Management.

**SECTION 2.** The City Council agrees that in the event of loss or misuse of the grant funds, the funds will be returned to the OOG/HSGD in full. The City Manager designates the City Emergency Manager, (SAOEM), as the grantee’s authorized official. The authorized official is given the power to apply for, accept, reject, alter, or terminate the grant on behalf of the applicant agency.

**SECTION 3.** Upon acceptance of this award, grant number 3458501, a new fund and internal order number will be created, upon which the sum not to exceed \$28,850.00 will be appropriated from the OOG/HSGD. A final and formal budget, which will include Internal Order numbers and General Ledger numbers, will be submitted by the department upon award.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This ordinance shall take effect immediately upon passage, provided that it is passed by eight or more affirmative votes; otherwise, this ordinance shall take effect ten days from the date of passage.
