AUTHORIZING THE EXECUTION OF A MEMORANDUM OF AGREEMENT WITH SAN ANTONIO INDEPENDENT SCHOOL DISTRICT (SAISD) TO MITIGATE THE LOSS OF THE 1915 BEACON HILL #22 STRUCTURE, LOCATED AT 1411 W. ASHBY PLACE AND IMPLEMENT MITIGATION STRATEGIES FOR SAISD STRUCTURES OF HISTORICAL SIGNIFICANCE.

WHEREAS, on November 7, 2018, the Historic and Design Review Commission found the 1915 Beacon Hill #22 structure located at 1411 W. Ashby Place to have Historical Significance and recommended this site for landmark designation; and

WHEREAS, Staff recommends that City Council end the designation process and authorize Director of the Office of Historic Preservation to negotiate and execute a Memorandum of Agreement with SAISD to mitigate the loss of Beacon Hill #22; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. City Council hereby directs city staff to end the historic landmark designation process for the property located at 1411 W. Ashby Place, San Antonio Texas 78201.

SECTION 2. City Council hereby authorizes the Director of the Office of Historic Preservation to negotiate and execute a Memorandum of Agreement with San Antonio Independent School District to mitigate the loss of the 1915 Beacon Hill #22 structure, located at 1411 W. Ashby Place and implement mitigation strategies for SAISD structures of historical significance.

SECTION 3. This Resolution shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage.
