

A RESOLUTION **2015-02-19-0015R**

**IN SUPPORT OF MEDIO SPRINGS RANCH APARTMENTS FOR THE 2015 COMPETITIVE 9% HOUSING TAX CREDIT APPLICATION PROCESS AS REQUIRED BY THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS.**

**WHEREAS**, Medio Springs, L.P., a Texas limited partnership (the “Applicant”), has proposed a 180 unit multi-family rental housing development to be located at 1530 Marbach Oaks named Medio Springs Ranch Apartments (the “Development”), in the Extraterritorial Jurisdiction of the City of San Antonio, Texas, County of Bexar; and

**WHEREAS**, the Applicant intends to submit an application to the Texas Department of Housing and Community Affairs (TDHCA) for 2015 Competitive 9% Housing Tax Credits for the Medio Springs Ranch Apartments; and

**WHEREAS**, the City of San Antonio has determined there is a need for additional affordable housing units for the proposed Development location; **NOW THEREFORE:**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City of San Antonio, County of Bexar, acting through its governing body, hereby confirms that it supports the proposed Medio Springs Ranch Apartments to be located at 1530 Marbach Oaks, TDHCA #15133, and that this formal action has been taken to put on record the opinion expressed by the City of San Antonio on February 19, 2015.

**SECTION 2.** The City of San Antonio hereby supports the proposed Medio Springs Ranch Apartments (the “Development”) and confirms that its governing body has voted specifically to approve the construction of the Development and to authorize an allocation of Housing Tax Credits for the Development.

**SECTION 3.** For and on behalf of City Council, the City Clerk is hereby authorized, empowered, and directed to certify this resolution to the Texas Department of Housing and Community Affairs.


**SECTION 4.** This Resolution is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


