

ORDINANCE 2018-12-06-0961

AWARDING A CONSTRUCTION CONTRACT TO D&G ENERGY CORPORATION IN AN AMOUNT NOT TO EXCEED \$591,989.00 FOR THE FY 2018 TRAFFIC SIGNAL INSTALLATION PACKAGE B TO CONSTRUCT THREE TRAFFIC SIGNALS, A 2018 TAX NOTE FUNDED PROJECT LOCATED IN COUNCIL DISTRICTS 3 AND 5.

WHEREAS, this Ordinance awards a construction contract for the construction of three new traffic signals at the intersections of (a) Ada Street and S. New Braunfels Avenue (Council District 3 - new traffic signal), (b) Goliad Road and Kate Schenck Avenue (Council District 3 - new traffic signal), and (c) N. Frio Street and Ruiz Street (Council District 5 - reconstruction of existing traffic signal); and

WHEREAS, City advertised for construction bids in August 2018 and opened bids in September 2018; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by D&G Energy Corporation in an amount not to exceed \$591,989.00 for the construction of three traffic signals;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The lowest responsive bid by D&G Energy Corporation for the FY 2018 Traffic Signal Installation Package B in the not to exceed amount of \$591,989.00, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever comes first.

SECTION 2. Payment not to exceed \$591,989.00 in SAP Fund 43099000, Certificates of Obligation Capital Projects, SAP Project Definition 23-01761, Warranted Traffic Signals, is authorized to be encumbered and made payable to D&G Energy Corporation, for construction services.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 4. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
