AUTHORIZING A CONTRACT WITH BUOY SERVICES, INC. D/B/A SURVIVAL AIR SYSTEMS FOR THE PURCHASE OF NINE AIR COMPRESSORS FOR A TOTAL COST OF \$243,999.00 FUNDED BY THE PUBLIC PROPERTY FINANCE CONTRACTUAL OBLIGATIONS, SERIES 2013 FUND.

WHEREAS, bids were submitted to provide City of San Antonio Fire Department with nine air compressors; and

WHEREAS, the low bid was submitted by Buoy Services, Inc. d/b/a Survival Air Systems for a total cost of \$243,999.00; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Buoy Services, Inc. d/b/a Survival Air Systems to provide City of San Antonio Fire Department with nine air compressors for a total cost of \$243,999.00, is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheet and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding in the amount of \$243,999.00 for this ordinance is available in Fund 29089012, Cost Center 2005070002, General Ledger 5501055 as part of the Fiscal Year 2014's Carry Forward.

SECTION 3. Payment not to exceed the budgeted amount is authorized to Buoy Services, Inc. d/b/a Survival Air Systems and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage hereof.
