

AN ORDINANCE 2017-05-11-0321

AN ORDINANCE AUTHORIZING THE EXECUTION OF TWO ON-CALL CIVIL ENGINEERING SERVICES AGREEMENTS WITH GONZALEZ, KYPUROS & WHITE, INC. AND AECOM TECHNICAL SERVICES, INC., EACH IN THE AMOUNT NOT-TO-EXCEED \$450,000.00 PER YEAR FOR A TERM OF ONE YEAR WITH ONE ADDITIONAL ONE-YEAR EXTENSION OPTION TO PROVIDE ON-CALL CIVIL ENGINEERING SERVICES FOR FEDERALLY FUNDED PROJECTS.

WHEREAS, City Council previously accepted \$1,700,000.00 in federal funds for FY 2017 from a Community Development Block Grant (CDBG) to complete infrastructure in the EastPoint Neighborhood and accepted \$400,000.00 in CDBG funds for the REnewSA Catalytic Investment; and

WHEREAS, previously, Transportation & Capital Improvements (TCI) contracted with two consultants that provided On-Call Civil Engineering Services for federally funded projects and those contracts expired in May 2017; and

WHEREAS, these contracts will improve efficiency and expedite delivery and completion of federally funded projects and specifically may include:

- Roadway and drainage design, preparation of construction plans and specifications;
- Environmental, surveying, and geotechnical engineering services;
- Site layout preparation, site grading design, site utility improvements, foundation design, parking lot design, accessibility pathways and site drainage design;
- Street maintenance/rehabilitation procedures and methods, sidewalk and ADA standards and general civil engineering services;
- Coordination and assistance with applicable permitting and code requirements, as required;
- Coordination and assistance with the bidding of documents, utilizing a variety of project delivery methods;
- Project administration to include project expenditure reports and contractor/subcontractor project activity reports;
- Periodic field observation/construction phase administration, as required;
- The development of professional recommendations and opinions, as required;
- Project management and cost estimating services; and

WHEREAS, this ordinance authorizes the execution of two On-Call Civil Engineering Services Agreements with Gonzalez, Kypuros & White (GKW), Inc. and AECOM Technical Services (AECOM), Inc., each in the amount not-to-exceed \$450,000.00 per year for a term of one year with one additional one-year extension option to provide On-Call Civil Engineering Services for Federally Funded Projects; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Gonzalez, Kypuros & White, Inc. and AECOM Technical Services, Inc. are selected for execution of two On-Call Civil Engineering Services Agreements to provide engineering services on an as-needed basis for Federally Funded Projects throughout the city.

SECTION 2. The City Manager or her designee is authorized to execute two On-Call Civil Engineering Services, each in the amount not-to-exceed \$450,000.00 per year, for a term of one year with one additional one-year extension option, to provide On-Call Civil Engineering Services for Federally Funded Projects.

SECTION 3. The following financial adjustments are hereby approved:

Funding for this ordinance will be identified when work orders are issued. Payment is limited to the availability of funding in the sources identified. All expenditures will comply with Grants Budgets for current and future fiscal years.

Payment not to exceed \$450,000.00 per contract per term is authorized to be encumbered with a purchase order and made payable to Gonzalez, Kypuros & White for on-call civil engineering services for federally funded projects.

Payment not to exceed \$450,000.00 per contract per term is authorized to be encumbered with a purchase order and made payable to AECOM Technical Services, Inc. for on-call civil engineering services for federally funded projects.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.


