AN ORDINANCE

AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION (TXDOT) FOR THE TEMPORARY STREET CLOSURE OF STATE RIGHT-OF-WAY ON BROADWAY STREET FROM PARLAND PLACE TO 4TH STREET AND THE TEMPORARY CLOSURE OF ROOSEVELT AVENUE FROM LONE STAR BOULEVARD TO MITCHELL STREET IN CONNECTION WITH THE THIRTEENTH SÍCLOVÍA EVENT, AS WELL AS ADDITIONAL TEMPORARY RIGHTS-OF-WAY CLOSURES, INCLUDING IH-37/NOLAN STREET GREEN SPACE AND IH-10/ROOSEVELT AVENUE GREEN SPACE, FOR SUBSEQUENT EVENTS, FOR ONE YEAR WITH A MUTUAL OPTION TO EXTEND AND CHANGE THE SÍCLOVÍA EVENT DATE EACH YEAR FOR UP TO FOUR ADDITIONAL YEARS.

WHEREAS, the San Antonio Metropolitan Health District received \$15.6 Million in funding from the Centers for Disease Control and Prevention through the 2009 Communities Putting Prevention to Work (CPPW) Initiative funded by the American Recovery and Reinvestment Act of 2009; and

WHEREAS, these funds are to be used to reduce and prevent obesity in children and adults by conducting activities in school and community settings across Bexar County; and

WHEREAS, as part of the CPPW initiatives, the thirteenth Siclovía event, sponsored by the YMCA, will take place on October 22, 2017 from 11:00 a.m. to 4:00 p.m. by temporarily closing portions of Broadway from Parland Place to 4th Street to allow bicyclists, skateboarders and pedestrians to move freely and to increase their use of bicycles and other forms of physical activity; and

WHEREAS, previous events were attended by approximately 55,000 attendees and received positive response from the community; and

WHEREAS, Broadway is a state-owned roadway, requested authorization from the Texas Department of Transportation (TXDOT) for the temporary closure of Broadway from Parland to 4th Street is required; and

WHEREAS, TXDOT's policy for authorization of temporary closures of state-maintained roadways are formally granted by agreement, which must be executed between governmental jurisdictions that will be impacted by the temporary road closures; and

WHEREAS, the Transportation and Capital Improvements staff is working with the YMCA developing the Traffic Control Plans, which will be utilized during the temporary street closures; and

WHEREAS, this City Council action will ensure that the temporary street closure from 5:00 a.m. to 5:00 p.m. on October 22, 2017 will be permitted for this event and subsequent events;
NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute a Temporary Closure Multi-Year Agreement with the Texas Department of Transportation to allow the temporary street closure of Broadway from Parland to 4th Street and the temporary closure of Roosevelt Avenue from Lone Star Boulevard to Mitchell Street for the city's Siclovía event which will be held on October 22, 2017, and additional temporary right of way closures that may include, but are not limited to, IH-37/Nolan Street green space and IH-10/Roosevelt Avenue green space for subsequent events.

SECTION 2. There is no financial impact with this Ordinance.

SECTION 3. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
