The City Council convened in a Regular City Council Meeting. Deputy City Clerk Leticia Saenz took the Roll Call and noted the following Councilmembers present:

PRESENT: 11 - Mayor Taylor, Treviño, Warrick, Viagran, Saldaña, Gonzales, Lopez, Medina, Nirenberg, Krier and Gallagher

Mayor Taylor announced that Councilmember Saldaña was attending the meeting via videoconference from Washington, D.C.

1. The Invocation was delivered by Associate Pastor Jeff Gaffney, Community Connect Church, guest of Councilmember Ray Lopez, District 6.
2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes for the City Council Meetings of June 29 - 30, 2016

Councilmember Gallagher moved to approve the Minutes for the City Council Meetings of

June 29-30, 2016. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

Councilmember Gallagher recognized Maria Hernandez who had served as an Intern for District 10. He thanked her for her great work and wished her well in her upcoming school year.

Councilmember Lopez recognized the Greater Helotes Girl's Softball Team for winning the Little League Softball World Series. Mayor Taylor added her congratulations to the team.

Items 16 and 17 were pulled for Individual Consideration. Mayor Taylor announced that Item 6 was pulled from the agenda by staff. Councilmember Warrick moved to approve the remaining Consent Agenda Items. Councilmember Treviño seconded the motion.

Mayor Taylor called the citizens registered to speak.

Dan Sturdivant stated that he was concerned with the development of the Pearl Complex located across from their homes (Item 14). He noted that their Homeowners Association would like additional information on the developer's plans.

ACTION ITEMS FOR STAFF BRIEFING

Mayor Taylor addressed Items 4A and 4B jointly. Deputy City Clerk Saenz read the captions for Items 4A and 4B:

4. Presentation of the City of San Antonio 2017 Proposed Operating and Capital Budget for the Fiscal Year beginning October 1, 2016 and consideration of the following related Ordinances. [Sheryl Sculley, City Manager]

- 4A. An Ordinance setting the proposed tax rate for the Tax Year 2016.

- 4B.** An Ordinance setting the public hearings on the proposed Budget for FY 2017 and on the proposed tax rate for Tax Year 2016.

City Manager Sculley recognized the Budget Staff that worked on the Proposed Budget. She presented the FY 2017 Proposed Operating and Capital Budget noting that the Budget was balanced. She reported that Public Safety was below 66% of the General Fund Budget and Financial Reserves totaled 15%. She stated that there was no City Property Tax Rate Increase proposed for FY 2017.

Mrs. Sculley highlighted the SA Speak Up Campaign which was utilized to gather public input on the Budget. She mentioned the Budget Goal Setting Session held with the City Council on June 8th which set Council Priorities. She reported that the FY 2017 City Budget totaled \$2.5 Billion which includes the General Fund, Restricted Funds, and Capital Budget. She stated that the General Fund would be increased by 3.4% and that Revenues were estimated to be 4.5% higher in FY 2017. She provided an overview of the Property Tax Distribution in which the City of San Antonio receives 22%. She noted that the Property Tax Rate was proposed to remain at 55.827.

Mrs. Sculley stated that the FY 2017 Budget includes 2 Planners for SA Tomorrow Plan Implementation and \$250,000 to begin a Comprehensive Plan Implementation Strategy. She reported that within Fire/EMS Services, two classes would be added and within the Police Department, 32 New Police Officers would be added. She highlighted the Five-Year Mediated Settlement Agreement and noted \$87.5 Million in Healthcare Cost Avoidance. She recommended the transfer of the Municipal Court Detention Center Operations to the Police Department and mentioned that a Task Force would study options for the future of the Detention Center and potential relocation of Municipal Court.

Mrs. Sculley reported that \$64 Million for Street Maintenance and \$15 Million for Sidewalks was included in the Budget. She stated that \$1 Million was allocated for Street Lighting, \$1 Million for Pedestrian Safety Around Schools, and \$1 Million for Pedestrian Safety Vision Zero. She noted that \$900,000 was being added to Animal Care Services (ACS) for additional positions and spay/neuter surgeries. She mentioned that Delegate Agency Funding totaled \$21 Million and that all Domestic Violence Prevention Agencies would be funded at the current FY 2016 Levels. She highlighted additional funding for Libraries, Parks, Center City, and Senior Services. She stated that \$75,000 would be allocated for an Air Quality Non-Attainment Public Health Study and \$75,000 for Non-Attainment Education & Outreach. She highlighted the funding allocated for the World Heritage Historic Missions and the Tricentennial Office.

Mrs. Sculley highlighted Smart Cities Initiatives that would focus on Transportation, Sustainability, and Digital Connected Living totaling \$13 Million. She noted that these include WiFi in Parks, Community Kiosks, and Solar Benches. She provided an overview of Employee Compensation and Benefits which include Wage Increases from 1% to 5% and additional Paid Parental Leave. She stated that they also recommended 24 hours of paid Wellness/Education Leave and Tuition Reimbursement for Trades and Applied Certificate Skills. She added that a Housing Incentive Program was recommended for Police and Fire Uniform Personnel that were First Time Homebuyers in the San Antonio City Limits.

Lastly, Mrs. Sculley presented the FY 2017 Capital Improvement Budget totaling \$585 Million. She reported that 92% of the 2012 Bond Program Projects were complete with 11 projects in the Design Phase. She highlighted the Alamodome Renovation Project scheduled for completion in November 2017 and the Consolidated Car Rental Facility Project scheduled for completion in December 2017. She mentioned that 5 Budget Community Open Houses and 2 Public Hearings would be held prior to budget adoption on September 15, 2016.

Mayor Taylor thanked everyone for their work on the budget and recognized citizens that have participated in the budget process thus far. She stated that this was a strong proposal that reflects many of the priorities of the City Council. She highlighted the savings related to Public Safety and noted she was pleased with the Smart City Initiatives included. She noted that she was also pleased with the recommended Paid Parental Leave and the Housing Incentives for Uniform Employees. She asked how citizens could access the proposed budget and provide feedback. Mrs. Sculley replied that they could attend one of four public hearings, watch via livestream, and could access the data and provide input through the city website. Mayor Taylor encouraged citizens to provide their input on the Proposed Budget.

Mayor Taylor called the citizens registered to speak.

Mike Phillips, Robert Cruz, and Minerva Cruz representing COPS/Metro Alliance addressed the City Council. Mr. Cruz stated that they were supportive of raising the entry-level wage for City Employees as well as funding for Project Quest at no less than \$2.2 Million. He thanked the City Council for their commitment and support.

Buddy Villejo addressed the City Council and noted that he had recently retired from the City of San Antonio. He stated that he was pleased with the city's commitment to reach an entry-level wage of \$15 per hour. He noted that he was also supportive of investing in neighborhoods and access to quality services.

Jennifer Arlen stated that she was a 9-1-1 Operator for the City of San Antonio and spoke of her experience when having a baby and not having enough money. She stated that it was important to implement policies to strengthen families.

Nazirite Ruben Flores Perez addressed the City Council and expressed support for the proposed budget. He noted that he was pleased with the improvements at City Parks and that property taxes would not be increased.

Councilmember Lopez thanked Mrs. Sculley for the presentation and stated that he was pleased with the input provided by the community. He stated that he would like to see a path to a \$15 Entry-Level Wage and noted the importance of strengthening families. Mrs. Sculley stated that they had reviewed the salaries last year and increased the Entry-Level Wage to \$13 per hour. She stated that when they reached the top level of their position; no one would receive less than \$15 per hour. She mentioned the issue of compression and stated that they would present further information during the Compensation Budget Work Session. She added that she was recommending funding in the amount of \$90,000 for Trades/Applied Certificate Skills.

Councilmember Viagran stated that she would also like to see the path to a \$15 Entry-Level Wage and that those that have reached the top of their Step Plan should also be justly paid. She thanked all of the entities and residents that have provided input on the budget. She stated that she was pleased with the position added for Translation Services and expanding the Office of Diversity and Inclusion. She noted support for the maintained funding for Delegate Agencies serving Domestic Violence Victims as well as the funding allocated for World Heritage. She highlighted the Improvements for the 9-1-1 Call Center and requested further discussion regarding a potential Investigator assigned to Human Trafficking within SAPD. She highlighted the Smart City Initiatives and the implementation of Wi-Fi and lighting at City Parks. She stated that this was one of the most transformative budgets presented and looked forward to more in-depth conversations. She added that the Council and staff be strategic and proactive with regard to SA Tomorrow and make investments in the Brooks Regional Center Area.

Councilmember Gallagher highlighted the fact that there was not a property tax increase and commended staff for maintaining the AAA Bond Rating. He stated that he was pleased with the funding allocated for infrastructure, additional personnel at the 9-1-1 Call Center, and increased staffing at the Northeast Senior Center. He requested that the Fire Union come back to the table to continue negotiations.

Councilmember Krier stated that they were committed to providing basic services and

asked how much would be spent for School Zone Safety. Mr. Frisbie replied that they allocated \$1 Million per year beginning in FY 2015 over five years. However, they were ahead of schedule and would be completed within four years. Councilmember Krier asked of the amount of funding for Streets and Drainage. Mr. Frisbie replied that \$64 Million had been allocated for Streets and Drainage while \$15 Million was allocated for Sidewalks. Councilmember Krier asked of the recommendation for New Police Officers. Mrs. Sculley replied that they were recommending 32 New Police Officers and had also submitted a grant for 25 additional Police Officers; as well as 9 Park Police Officers. She stated that the new positions would be in addition to filling vacancies. Councilmember Krier asked if there were any issues with recruiting Police Cadets. Chief McManus stated that they had not had any issues and many individuals were interested in becoming a Police Officer. Councilmember Krier recognized representatives from COPS/Metro and highlighted the work of Project Quest. He recognized Mayor Taylor for her leadership on the Police Collective Bargaining Agreement.

Councilmember Saldaña stated that he was pleased with the paid leave for new parents and asked for additional information. Mrs. Sculley stated that maternity/paternity leave would be available to employees as parenting was a shared responsibility. Councilmember Saldaña asked of the printing costs for the public at Libraries and if it had been reduced. Mrs. Sculley replied that they reduced the cost to \$0.20 per page but would review to potentially reduce it further. Councilmember Saldaña referenced the move of the Detention Center to SAPD from Municipal Court. Mrs. Sculley stated that the Municipal Court Judge did not supervise day-to-day operations and the facility would be better supervised by Police Officers. She noted that they would study a long-term partnership with Bexar County and that there would not be a fiscal impact. Councilmember Saldaña spoke of the partnership with Local Initiatives Corporation (LISC) and asked for additional information. Mrs. Sculley stated that the San Antonio Area Foundation was helping LISC come to San Antonio to build more affordable housing in the community. Councilmember Saldaña spoke of the Entry-Level Wage and requested a list of employees earning \$13 per hour. He noted support for Translation Services and the enhancements for the Northeast Senior Center.

Councilmember Nirenberg referenced Slides 16 and 18 and asked of the property tax data. Mrs. Sculley clarified that Slide 16 referenced Revenues while Slide 18 related to Assessed Valuation. Councilmember Nirenberg asked of the Bond Rating Agencies and changing expectations. Mrs. Sculley stated that the Bond Rating Agencies were constantly updating the criteria for which they evaluate cities. Councilmember Nirenberg asked of the Contingency Fund and use of these funds for FY 2016. Mrs. Sculley replied that a Contingency Fund was included in the proposed budget in the amount of \$1 Million. Maria Villagomez noted that there were challenges related to CPS Energy Revenue and a portion of the funds were utilized to address that shortage this year. She added that funds were also

allocated for SA Pets Alive.

Councilmember Medina highlighted Public Safety and asked if TCI Staff had the resources necessary for the 2017 Bond Program. Mr. Frisbie responded that they were prepared for the 2017 Bond Program. Councilmember Medina stated that he was supportive of the initiatives included for City Employees including a pathway to a \$15 Entry-Level Wage.

Councilmember Gonzales asked of the funding allocated for the Residential Lighting Program. Mrs. Sculley replied that they had increased said item in the last two budgets and recommended another \$1 Million in the FY 2017 Proposed Budget. Councilmember Gonzales asked of the increase for Animal Care Services (ACS). Mrs. Sculley stated that the funds would be used to add two Animal Care Officers for Districts 3 and 4. Additionally, they would add three new positions for the Return-to-Owner Program and 5,000 more spay/neuter surgeries. Councilmember Gonzales stated that she was supportive of ACS but noted concerns with the large budget increase. She stated that she had a personal experience with 9-1-1 and commended staff for their work.

Councilmember Warrick stated that he was pleased with the new Library that would be opened in District 2. He noted support for the dedicated ACS Staff for District 3 which would also help District 2. He asked of the LISC Funds and if they were reviewing older public housing as well as new public housing. Mrs. Sculley stated that she was not prepared to discuss the details at this time but would invite their Director to the Budget Work Session. Mayor Taylor noted that she was supportive of LISC and that they focused on Affordable Housing in neighborhoods working in partnership with public entities and non-profit organizations. She added that although they were known for providing housing assistance; their focus was on Neighborhood Revitalization. Councilmember Warrick asked how the \$1 Million for Residential Street Lighting would be allocated. Mrs. Sculley stated that she would provide a list of recommended areas based on need. Councilmember Warrick asked of mentoring, training, or other professional development opportunities for the employees at the Entry-Level Wage. Mrs. Sculley spoke of the various education and training opportunities available for City Employees.

Councilmember Treviño stated the he was pleased to improve Spanish Translation Services which was inclusive, transparent, and brought Social Equity. He noted that high technology could be implemented in a low-tech way and noted that they should invest in helping people and their quality of life. Mayor Taylor added that the budget must reflect a commitment to neighborhoods and would like to have a further conversation about working with Neighborhood Associations to maintain their quality of life.

Councilmember Lopez moved to adopt the Ordinances for Items 4A and 4B.

Councilmember Medina seconded the motion. The motion prevailed by the following vote:

AYE: 11 - Mayor Taylor, Treviño, Warrick, Viagran, Saldaña, Gonzales, Lopez, Medina, Nirenberg, Krier and Gallagher

Councilmember Saldaña signed off the meeting at this time.

She added that now that children were back in school, they would receive notifications from School Nurses and have a better focus on this population.

Councilmember Viagran moved to adopt the Ordinance for Item 16. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

Councilmember Viagran moved to adopt the Ordinance for Item 17. Councilmember Medina seconded the motion. The motion prevailed by the following vote:
