**AUTHORIZING THE EXTENSION OF LINE-OF-DUTY INJURY LEAVE
FOR SAN ANTONIO FIRE DEPARTMENT FIRE ENGINEER VENTURA
CALDERON JR.**

WHEREAS, section 143.073 of the Texas Local Government Code provides that a firefighter injured in the line of duty is entitled to line-of-duty injury leave with full pay for a period commensurate with the injury and not to exceed one year; and

WHEREAS, section 143.073 also provides that a municipality's governing body may extend the line-of-duty injury leave beyond one year; and

WHEREAS, San Antonio Fire Department Fire Engineer Ventura Calderon Jr. was injured in the line of duty on May 6, 2014, and, as a result, required leave in excess of one year to address said injury; and

WHEREAS, Fire Engineer Calderon is requesting an extension of line-of-duty injury leave beyond one year for the period June 18, 2015, to September 17, 2015; and September 4, 2019 to December 8, 2019; and


WHEREAS, approving the requested extension will restore 1,046 hours of accrued leave to Fire Engineer Calderon; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. An extension beyond one year of San Antonio Fire Department Fire Engineer Calderon's line-of-duty injury leave for the period June 18, 2015 to September 17, 2015 and September 4, 2019 to December 8, 2019 is hereby approved.

SECTION 2. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
