AN ORDINANCE 2017 - 06 - 22 - 0496

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION IN THE AMOUNT OF \$50,000.00 TO THE FOX THEATRE INSTITUTE PRESERVATION GRANT PROGRAM FOR THE PURPOSE OF PURCHASING AND INSTALLING EQUIPMENT IN THE JO LONG THEATRE AND LITTLE CARVER CIVIC CENTER, ACCEPTING FUNDS UPON AWARD, PROVIDING MATCHING FUNDS AND AUTHORIZING ANY NECESSARY AGREEMENTS.

WHEREAS, Fox Theatre Inc. has expanded its Fox Theatre Institute Grants Program and Historic Preservation Services and provides funding in support of historic facilities across the nation; and

WHEREAS, the Carver Community Cultural Center ("Carver") is a multicultural and multidisciplinary performing and visual arts center with an emphasis on the contributions of African and African-American artists and there exists a constant need for the upgrading or replacement of theatre equipment to keep the Carver current with industry standards; and

WHEREAS, if selected to receive these grant funds, the City intends to utilize the money for the purchase and installation of equipment that will expand accessibility and availability of programming, such as assistive listening access, seating, listening devices, staging, sound and lighting equipment and projection systems; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The submission of a \$50,000.00 grant application to Fox Theatre Institute Preservation Grant Program by the City of San Antonio, through the Carver, for the purpose of purchasing and installing equipment on the Jo Long Theatre and the Little Carver Civic Center, and the acceptance of such funds, upon award, are authorized and approved.

SECTION 2. The City Manager, or her designee, is authorized to execute any and all documents necessary to the application and acceptance of this grant.

SECTION 3. Fund 29657000 entitled "Carver CTR- Org Support/Events" and Internal Order 28000000005 are designated for use in the accounting for the fiscal transaction of this grant.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.
