BACKGROUND INFORMATION:

The Joint City/County Citizens Bond Oversight Commission is comprised of 20 members. The San Antonio

City Council and the Bexar County Commissioners Court each appoint 10 members to serve on the Commission. Appointments are made to ensure representation from all sectors of the City of San Antonio and Bexar County. Kenneth Thomas, Chair of the Commission was selected jointly by Mayor Castro and County Judge Wolff. Members will serve two-year terms.

ISSUE:

Board appointments require full City Council approval.

FISCAL IMPACT:

There is no fiscal impact.

RECOMMENDATION:

The Office of the City Clerk recommends that the Governance Committee make a recommendation for vacancies to the Joint City/County Citizens Bond Oversight Commission. The City Council will consider said item on October 30, 2014.
