- The City of San Antonio will conduct a public hearing to name the Thunderbird Hills Park to Jane Dubel Park on June 23, 2015, as required by Article XVI of Chapter 6 of the City Code. Comments, oral or written, concerning the naming of the Thunderbird Hills Park to Jane Dubel Park from all interested citizens will be considered.

Jane Dubel has been the President of the Thunderbird Hills Neighborhood Association for the past twelve years. She has dedicated her time and effort in pursuit of projects beneficial to the organization and community. Some of the initiatives have been sidewalks, speed bumps, National Night Out events, and toy and/or fund drives for the Wounded Warriors at the Fort Sam Houston Fisher House.

Mrs. Dubel worked for more than twelve years for the acquisition of land for the development of a neighborhood park in District 7. She advocated to the Bond Committee and elected officials for a new park to be considered as part of the 2012-2017 Bond Program. As a result of her efforts the voter approved Bond Program included \$350,000 towards acquiring and developing a new park in the Thunderbird Hills neighborhood. She helped to secure the resources of Disney/ESPN to acquire the park playground equipment through a KaBoom! grant. She was also a big part of the driving force behind getting volunteers to help on the build day for this initiative in November 2014.

Naming the Thunderbird Hills Park to Jane Dubel Park will commemorate and recognize this long-time civic leader for her invaluable contributions to the community.
