The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

**Present:** 7 - Mayor Taylor, Toney, Saldaña, Gonzales, Nirenberg, Krier and Gallagher

**Absent:** 3 - Viagran, Lopez and Medina

Mrs. Vacek announced that Councilmembers Viagran, Lopez and Medina were out of the city.

1. The Invocation was delivered by Pastor Richard Robles, Igniting The Harvest Church, guest of Councilmember Shirley Gonzales, District 5.
2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.

**POINTS OF PERSONAL PRIVILEGE**

Mayor Taylor and the City Council recognized Councilmember Bernal for his service to the City of San Antonio. Mayor Taylor presented a Plaque of Appreciation to Councilmember Bernal. Councilmember Bernal thanked the City Council for the gift and recognition.

Mayor Taylor recognized the San Antonio Lighthouse for the Blind for their 80 years of service. Representatives from the San Antonio Lighthouse for the Blind were present to accept the certificate and thanked the City Council for the recognition.

Councilmember Nirenberg asked if there were any administrative issues with said items. Troy Elliott replied that there had been some items that came up during the process including several bids not accepted because they did not meet the subcontracting requirements. He stated that there was an issue with a Subcontractor that had been replaced and one protest received on the scoring. He noted that after further review; they believed the process had been fair and equitable. Councilmember Nirenberg asked if the item had been presented to the High Profile Contracts Committee. Mr. Elliott confirmed that the

item had been presented but noted that one of the protests had been received after the meeting.

Mayor Taylor recognized Samuel Salas who registered to speak on said item.

Mr. Salas stated that his company was Unified Service Associates and they were one of the finalists on the two bids in questions. He noted concerns that 3rd Generation Services, LLC had utilized the name of his subcontractor on their bid.

Alex Lopez, Assistant Director of the Economic Development Department explained that staff reviewed Utilization Plans submitted to ensure that Subcontracting Goals were met. She stated that if there were any concerns; the Prime Contractor was allowed to make changes before Council Approval. She indicated that 3rd Generation Services, LLC was still meeting their Subcontracting Goals and recommended for approval.

Councilmember Toney asked of the issue on the Subcontractor. Ms. Lopez replied that the Subcontractor could no longer perform the work and the Prime was able to find another Subcontractor.

Councilmember Nirenberg moved to adopt the proposed ordinances for Items 10A and 10B. Councilmember Saldaña seconded the motion. The motion prevailed by the following vote:

Mayor Taylor asked staff to highlight said item. Mr. Xavier Urrutia stated that the City of San Antonio had acquired property through a land swap with the San Antonio Housing Authority last year. He noted that it was located in the Lavaca Neighborhood and was part

of the revitalization in the area. He commended Coca-Cola and the National Recreation and Park Association for their grant and partnership noting that they would add programming and engagement targeted toward youth. Ms. Luisa Casa representing Coca-Cola added that they were pleased to commit to the health and wellness of the City of San Antonio. Mr. Curtis Bowers of the Lavaca Neighborhood Association thanked everyone for their work and stated that he looked forward to the revitalization of the park. Mayor Taylor thanked Coca-Cola for their continued commitment to the City of San Antonio.

Councilmember Gallagher stated that this was a wonderful opportunity for the City of San Antonio and was pleased with the partnership. Councilmember Toney added that Coca-Cola had been a great partner and appreciated their support.

Councilmember Gallagher moved to adopt the proposed ordinance. Councilmember Nirenberg seconded the motion. The motion prevailed with the following vote:

Councilmember Toney stated that this was an exciting project for the city and District 2 which would transform the area and change its dynamics.

Mayor Taylor called upon the citizens registered to speak.

Eugene Simor thanked Mayor Taylor and Councilmember Toney for their continued support of the project. He commended City Staff for their efforts to get the project done and stated that he was pleased with the support of the Neighborhood Association.

Juan Garcia stated that he was a resident of the neighborhood and Immediate Past President of the Neighborhood Association. He noted that the project would help revitalization efforts on the East Side and hoped it would spur additional private investments.

Councilmember Krier asked of the incentive package. Ms. Lori Houston stated that the

City Council had approved \$800,000 in incentives in August 2012 of which \$450,000 was allocated from a Tax Rebate for the City Taxes on their project. She noted that they received a Public Improvement Grant in the amount of \$295,000 to improve the area around the bridge and a \$50,000 Retail Recruitment Grant. She indicated that the amendment was necessary to revise the location for the brewery and completion date. Councilmember Krier expressed his support and stated that it would have a great impact on the East Side.

Councilmember Nirenberg expressed his support and noted that he was impressed with Mr. Simor's involvement in Non-Profits and his community support.

Councilmember Gonzales expressed her support and spoke of the great amount of time the project had taken thus far. She commended Mr. Simor for his persistence in making the project happen and thanked everyone for their work.

Mayor Taylor expressed gratitude to everyone that helped the project get to this point. She stated that neighborhood change was difficult but this project would help revitalize the area.

Councilmember Saldaña added his congratulations for the project and stated that he was pleased with the private investment.

Councilmember Toney moved to approve said item. Councilmember Saldaña seconded the motion. The motion prevailed with the following vote:

- 32.** Public Hearing and consideration of an ordinance creating a new City-initiated Tax Increment Reinvestment Zone, to be named reinvestment zone number thirty-three, City of San Antonio, Texas, also known as "Northeast Corridor TIRZ" located in City Council Districts 10 and 2; authorizing the creation of a seven member Board of Directors, establishing the effective start date and termination date of the zone, approving preliminary Project and Finance Plans and establishing a tax increment fund. [Peter Zaroni, Deputy City Manager; John Dugan, Director, Planning and Community Development]

Councilmember Gallagher asked staff to briefly present the North East Corridor Tax

Increment Reinvestment Zone (TIRZ). Mr. John Dugan presented a Power Point noting that it had been a multi-year effort to bring vitality to the Perrin Beitel and Nacogdoches Corridors of the city. He stated that they had reviewed different alternatives and found the TIRZ to be the best opportunity to improve the area. He estimated that the TIRZ would generate \$6 Million over the 20-year term and increment \$300,000 per year that could be used for new development projects. He mentioned that the funds could be used for grants, gateway enhancements, lighting and public art. He added that staff recommended approval with Tax Increment Collections to begin in 2015. Councilmember Gallagher thanked everyone for their work and stated that this would greatly benefit the area. He recognized former District 10 Councilmembers Soules, Clamp, and Haass that were present.

Mayor Taylor called upon the citizens registered to speak.

Milton McFarland stated that he had been a resident of District 10 for over 33 years and was in support of the TIRZ. He spoke of the history of Perrin Beitel and noted that the TIRZ would increase incremental real property taxes resulting from new construction, public improvements, and redevelopment efforts.

Roger Martinez stated that he was representing the El Chaparral Neighborhood Association and Urban Hills Homeowners Association in support of the TIRZ. He spoke of the great improvements that were already occurring in the Northeast Corridor and thanked the City Council for their support.

John Clamp addressed the City Council in support of the NEC TIRZ. He stated that the decision would transform and was confident it would help revitalize the area.

Carlton Soules expressed his support and stated that this was a crucial step in a process that had begun four years ago. He noted that they had expanded the Inner City Reinvestment Infill Policy (ICRIP) to bring incentives to aging commercial corridors. He added that this was an important venture that would expand and improve the area.

Councilmember Toney stated that the Perrin Beitel Corridor was ripe with opportunity and commended Councilmember Gallagher for his leadership. Councilmember Krier expressed his support and commended all of the District 10 Councilmembers that were present. He noted that the TIRZ designation could be a catalyst for change.

Councilmembers Nirenberg expressed his support and stated that he lived in the area 15 years ago when he was first married. He noted that this was a key corridor in the city and could be a catalyst for San Antonio. Councilmember Saldaña added his support and stated that there were many commercial corridors in the city that were in decline.

Mayor Taylor thanked the Former Councilmembers for their service to the City of San Antonio and congratulated Councilmember Gallagher on moving this project forward.

Councilmember Gallagher moved to adopt the proposed ordinance. Councilmember Toney seconded the motion. The motion prevailed by the following vote:

### 35. City Manager's Report

- A. Boarding Homes Update
- B. World Stem Cell Summit

A. Mrs. Sculley reported that the Boarding Home Ordinance was approved by the City Council on December 13, 2012 and went into effect on March 1, 2013. She noted that since March 2013; the Boarding Home Team had investigated 2,173 properties. She reported that 120 elderly and/or disabled residents were currently in safer living conditions due to the effectiveness of the ordinance. She stated that of 110 Boarding Homes identified; 21 were still in operation and 89 had shut down. She mentioned that the cost of installing sprinkler systems had reportedly decreased over the past year and therefore; more Boarding Homes were expected to be permitted this year. She added that the city would continue to enforce the ordinance through the Civil and Criminal Court Process to gain compliance or closure of the remaining Boarding Homes operating illegally.

B. Mrs. Sculley reported that the City was hosting the 10th Annual World Stem Cell Summit (WSC) this week which started on Tuesday, December 2nd and ends Friday December 4th. She stated that 1,400 attendees from 40 countries were expected to attend. She noted that the Summit was the world's largest meeting of Researchers, Scientists, Clinicians, Regulators, Patient Advocates and Investors engaged in the field of Stem Cell Research and Therapies. She mentioned that the field of Regenerative Medicine was key to growth in the City's Bioscience Industry and the City was poised to capitalize on this opportunity by partnering with local companies like StemBioSys, Inc. and BioBridge Global. She stated that the San Antonio Economic Development Corporation (SAEDC) played a vital role in persuading the Stem Cell Summit to choose San Antonio for its Annual Conference. However, this was a community-wide effort that included support from partners like BioMed SA, UTSA and Texas Research & Technology Foundation. She noted that there was substantial private sector support from local entities like StemBioSys, Incell and Targeted Technology. She mentioned the major sponsors of the WSC Summit: UT Health Science Center, BioBridge Global, the Texas Biomedical Research Institute and

Southwest Research Institute. She stated that in anticipation of the Summit, she visited BioBridge Global and StemBioSys Manufacturing Facilities on a Business Retention and Expansion visit a few weeks ago. She stated that BioBridge was a crucial part of the City's Bioscience Industry with four major subsidiaries: 1) The South Texas Blood & Tissue Center; 2) QualTex Laboratories; 3) GenCure; and 4) The Blood and Tissue Center Foundation. She added that the WSC Summit and tour of BioBridge Global made it clear that the field of Regenerative Medicine was key to continuing the growth in the City's Bioscience Industry.

Mayor Taylor and the City Councilmembers expressed their support for the Stem Cell Summit and thanked staff for the Boarding Homes Update.
