#### AN ORDINANCE

AUTHORIZING SUBMITTAL OF FOUR PROJECTS FOR FUNDING CONSIDERATION THROUGH THE FY 2015-2018 TRANSPORTATION IMPROVEMENT PROGRAM BY THE SAN ANTONIO-BEXAR COUNTY METROPOLITAN PLANNING.

**WHEREAS,** the San Antonio - Bexar County Metropolitan Planning Organization (MPO) has issued a "call for projects" to all agencies for a list of projects for funding consideration through the FY 2015-2018 Transportation improvement Program; and

**WHEREAS,** City Staff recommends the submittal of the following four projects for funding consideration by the MPO; and

#### Strategic Multi-Modal Transportation Plan

Implementation of the San Antonio - Bexar County Comprehensive Transportation Plan Micro-Model and creation of a San Antonio Strategic Multi-Modal Transportation Plan in the amount of \$3,000,000.

## Callaghan Road Project Extension (Bandera to Loop 410)

Expanding the limits of the Callaghan Road Project Extension north to Bandera Road and south to Loop 410 for additional capacity in the amount of \$2,500,000.

#### Presa Ramps at Hwy 90

An operational improvement project that will add an entrance ramp on westbound US 90 and an exit ramp on eastbound US 90 in the Presa Street area in the amount of \$30,000,000.

### Harry Wurzbach / Austin Highway Intersection

An operational improvement project to construct new entrance and exit ramps at the intersection of Harry Wurzbach and Austin Highway to improve safety and connectivity in the amount of \$10,000,000.

**WHEREAS,** City Council concurs with staff's recommendation of projects for funding consideration to the MPO: **NOW THEREFORE**;

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1**: City Council authorizes submittal of the following four projects for funding consideration by the MPO:

Strategic Multi-Modal Transportation Plan (\$3,000,000)

Callaghan Road Project Extension (Bandera to Loop 410) - (\$2,500,000)

Callaghan Road Project Extension (Bandera to Loop 410) - (\$2,500,000)

Harry Wurzbach / Austin Highway Intersection (\$10,000,000)

**SECTION 2**: This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
