

AN ORDINANCE 2016-02-11-0084

REAPPOINTING COUNCIL MEMBER REBECCA J. VIAGRAN (AT-LARGE, CATEGORY: COMMUNITY REPRESENTATIVE) AND CARROLL SCHUBERT (AT-LARGE CATEGORY: SAN ANTONIO BUSINESS COMMUNITY REPRESENTATIVE) TO THE INTERMUNICIPAL COMMUTER RAIL DISTRICT (LONE STAR RAIL DISTRICT) FOR THE REMAINDER OF THEIR RESPECTIVE UNEXPIRED TERMS OF OFFICE.

WHEREAS, the City of San Antonio has received a request from the Lone Star Rail District seeking the reappointment of the appointees representing the City on the Rail District board; and

WHEREAS, Council member Rebecca Viagran and former Council member Carroll Schubert are the two City representatives on the Rail District Board, and both are eligible for reappointment; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Council member Rebecca Viagran (District 3) (Category: San Antonio City Council Member) and Carroll Schubert (Category: San Antonio Business Community Representative) are reappointed to the board of directors for the Lone Star Rail District for the remainder of their respective unexpired terms.

SECTION 2. This Ordinance is effective immediately upon the receipt of eight affirmative votes, otherwise, it is effective ten days after passage.
