# **ROLL CALL**

The City Council convened in a Regular Meeting. City Clerk Leticia M. Vacek took the Roll Call noting a quorum with the following Councilmembers present:

- 1. The Invocation was delivered by Pastor Robert C. Arevalo, Grace Tabernacle Church, guest of Councilmember Rebecca Viagran, District 3.
- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
- 3. Approval of Minutes from the City Council Special Meeting of August 20, 2019 and the City Council Regular Meetings of August 21 22, 2019.

Councilmember Andrews-Sullivan moved to approve the August 20, 21, and 22 Minutes. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

# **POINTS OF PERSONAL PRIVILEGE**

Mayor Nirenberg read a Proclamation recognizing Indigenous Peoples Day on October 14, 2019 and celebrates future dates on the second Monday of the Month of October. He added that the celebration was in recognition of past, present, and the future of San Antonio. Mayor Nirenberg noted that the Indigenous People were the earliest known inhabitants of our city and played a critical role in shaping the long rich history of San Antonio.

Councilmember Sandoval announced National Chiropractic Health Month and welcomed Dr. Tremble to the podium to receive the Proclamation. Mayor Nirenberg read a proclamation recognizing National Chiropractic Health Month.

Councilmember Rocha Garcia announced "Day of the Girl" on October 11, 2019. She added that as a result of youth advocacy around the world: the United Nations has declared "International Day of the Girl" with the mission to galvanize enthusiasm with goals of advancing girls' lives and providing opportunity for leadership.

# **CONSENT AGENDA ITEMS**

Items 18, 21, and 25 were pulled for Individual Consideration. Councilmember Andrews-Sullivan moved to approve the remaining Consent Agenda Items. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Mayor Nirenberg called upon the citizens registered to speak:

Olga Martinez spoke in opposition of Item 30 amending the Major Thoroughfare Plan to realign and redesign a segment of East and West Connector. She noted that she represents the District 3 Neighborhood Association. She added that the project affected the corner of 410 South and Roosevelt. Ms. Martinez stated that the proposed four-lane highway would enter Roosevelt which was experiencing problems with pedestrian safety with 23 fatalities at that location.

Jack M. Finger spoke in favor of Columbus Day, noting that he brought the Christian Religion to civilization. Mr. Finger spoke in opposition of Item 24 approving amendments to the City of San Antonio's Federal Legislative Program for the 116<sup>th</sup> U.S. Congress.

# **CONSENT ITEMS CONCLUDED**

# **ITEMS PULLED FOR INDIVIDUAL CONSIDERATION**

City Clerk Vacek read the caption for Item 4:

#### 2019-10-03-0795

4. Ordinance amending Article XI, Chapter 15, of the City Code of San Antonio entitled "Earned Paid Sick Time"; and setting the effective date for December 1, 2019. [Colleen M. Bridger, MPH, PhD, Assistant City Manager; Jennifer Herriott, MPH, Interim Director, Health]

Colleen Bridger, Assistant City Manager provided a presentation on the recommended revisions of the San Antonio Paid Sick Leave (PSL) Ordinance approved by the City Council August 12, 2018. She reported that Mayor Nirenberg established an Ad-Hoc Committee to review options for revising the PSL. Ms. Bridger recognized Danielle L. Hardgrove Chairwoman of the PSL Ad-Hoc Committee.

Mrs. Laura Mays provided the public engagement summary reporting that surveys were open from September 16<sup>th</sup> through September 30, 2019; 2,652 respondents participated. Mrs. Mays stated that over 200 individuals participated in the public meetings conducted and 1,700 individuals viewed the live stream of the public meetings.

Mayor Nirenberg called upon the individuals registered to speak:

Christina Alderete, President of the North Chamber of Commerce spoke in opposition of the PSL Ordinance. She added that it was on overreach of municipal government. She stressed that private employers provide employee compensation and benefits to their employees and that the City should not mandate unfunded regulations to private businesses. She added that PSL was addressed by provisions contained within the Texas Labor Code.

Don Dixon spoke in opposition of the PSL Ordinance adding that he founded a company in 1962 and it has grown to 150 employees. He added that San Antonio was a great city for the manufacturing business but that would be tarnished if PSL was approved. He added that local government should not interfere in the relationship between employee and employer of private employment.

Jolene Garcia representing the Texas Organizing Project spoke in favor of the PSL Ordinance. She noted that 39% of individuals living in San Antonio had no access to paid time off to utilize when they become ill. She stated that approving PSL today would reaffirm the Council's commitment to safeguarding public health.

Kevin Lamelle spoke in favor of the PSL Ordinance noting that he worked in the sports and entertainment business. He added that he had to go to work sick because he did not have PSL. He stressed the importance of having the ability to stay home when sick so that his co-workers do not get sick.

Michelle Tremillo spoke in favor of the PSL Ordinance noting that her husband had a good job but he does not get paid when he was sick. She stated that PSL was needed to protect individuals that need to stay home and more importantly, that they will get paid utilizing PSL.

Linda Chavez-Thompson spoke in favor of the PSL Ordinance and thanked Councilmember Gonzales for appointing her to the PSL Commission. She added that she represented AFL-CIO Labor Council for a total of 26 unions and over 30,000 union members in Bexar County. She noted that individuals do not get paid when they become sick and have to stay home. She mentioned the PSL Commission members spent many hours creating draft recommendations for City Council. She urged that Council to approve the recommendations as presented.

Irene White spoke in favor of the PSL Ordinance noting that she is a community health worker with the Martinez Street Women's Center. She described their mission to provide access to vital health services, quality education, and advocacy. She added that their non-profit envisions a world where women and

girls achieve empowerment, equity, and justice. She stated that Martinez Street Women's Center supports PSL because it will allow women to not lose income when they need to take care of their health or their children's health.

William Gaskins spoke in favor of the PSL Ordinance adding that he owns a business with two employees. He noted that his two employees accrue paid time off and paid sick leave their first day of employment. He added that PSL was very important to the community and the right thing to do.

Drew Galloway, Director of Move Texas spoke in favor of the PSL Ordinance noting that PSL was a quality of life issue. He commended the PSL Commission for their time and effort. He added that the PSL Commission sought input from Business Owners, Chambers of Commerce, Business Executives, Community Organizers, Faith Leaders, Labor Organizations and Health experts.

Sharon Aguillen, President of San Antonio Tourism Council spoke in opposition of the PSL Ordinance noting that she represents approximately 120 small business owners. She added that small businesses were not against PSL and noted that several small businesses already provide PSL. She stressed their opposition to a government mandated benefit involuntarily enacted onto private business.

Judith Vega, representative with the Esperanza Peace and Justice Center spoke in favor of the PSL Ordinance. She noted that the passage of PSL will help break the cycle of poverty. She added that her spouse's employer did not offer PSL and that he had to go to work sick because they could not afford a day off without pay. She urged that Council to approve PSL.

Andres Cruz spoke in opposition of the PSL Ordinance noting that he has owned a business for the past 20 years and has 650 employees. He added that imposing PSL would place a financial burden on his business and would cost approximately \$252,000 annually.

Sean Vina, Medical Sociologist and Researcher at the Texas Health University spoke in favor of the PSL Ordinance. He added that Latinos have 40% lower odds to use their healthcare services with PSL. He noted that those below college education are 30% less likely to use healthcare services than those with a degree. He added that 75% of San Antonio had below a college education. He urged that Council determine the barriers to using PSL and create policy that specifically targets disadvantaged groups that need PSL.

Sarah Donaldson, Employment Attorney spoke in favor of the PSL Ordinance noting that the lawsuit filed by big business was meritless. She added that paying sick leave for hours not worked does not increase an employee's hourly wage. She urged that Council approve PSL.

Ellen Berky spoke in favor of the PSL Ordinance noting that this was an economic and racial justice issue that disproportionately affects women. She added that low wage workers were least likely to have paid time off for caregiving and must take unpaid time off from work. She stated that unequalled access to paid leave exacerbates inequity and reinforces gender and racial stereotypes.

Christopher Herring, Chairman of the Small Business Advocacy Committee spoke in opposition of the PSL Ordinance. He noted that he has studied small, minority, women owned, veteran, and local business. He added that the passage of PSL would economically and negatively impact the small business bottom line.

Juanita Sepulveda stated that she was a minority women owned and disabled veteran and spoke in opposition of the PSL Ordinance. She added that she is the Vice Chair of the Small Business Advocacy Committee. She noted that there are 61,461 businesses in San Antonio. She stated that PSL was a federal issue and that the Sick Leave Act was in Federal Court now. She urged that Council to postpone the vote until the Federal Court resolves the case before their court.

Margaret Trevino spoke in favor of the PSL Ordinance and urged the Council to consider interns and temporary workers; adding that they need PSL and they did the equivalent work as full time workers.

Antonio Diaz spoke in support of the PSL Ordinance and noted that the people signed petitions for sick leave. He added that elected officials had tough jobs representing constituents and all the different views. He urged the Council to approve PSL and thanked them for listening to the voters.

Jack M. Finger spoke in opposition of the PSL Ordinance adding that a governmental body should not mandate businesses to provide PSL. He stated that PSL requires pay for work not done and added that people should not be paid when they are sick.

Mayor Nirenberg stated that paid sick leave petitioners gathered enough signatures to allow the City to consider PSL. He added that he created a PSL Commission to research and recommend a draft policy. He noted that several public meetings were conducted and online surveys were utilized to gather refinements to the PSL Ordinance. He noted that he was impressed and grateful for the thorough public process. He added that he was happy to recommend changes including provisions to protect those experiencing unsafe circumstances at home.

Additionally, Mayor Nirenberg mentioned that October was Domestic Violence Awareness Month and that the City approved \$1 million in the FY 2020 Budget to combat Domestic Violence. He added that the PSL Ordinance would serve as an extension to the Council's commitment to the community, to the well-being of all residents in San Antonio.

Councilmember Sandoval stated that their next vote was about changes to the current Ordinance that was approved August 16, 2018. City Attorney Andy Segovia reported that the proposed action before Council was draft revisions to the PSL Ordinance. He added that it included draft language provided by the Commission and by City Council during B Session. He noted that if nothing was changed or voted on today, the current PSL Ordinance would stay in place as approved August 16, 2018 with one caveat. He noted that the only caveat was from litigation in that the City agreed to postpone implementation until December 1, 2019.

Councilmember Sandoval thanked the people that brought forth the petitions for PSL and those that served on the PSL Commission. Councilmember Sandoval listed the biggest challenges residents face are low birth outcomes, amputees from diabetes, epidemic levels of domestic violence, and the poorest large metropolitan area in the nation. She reported that once the PSL Ordinance was implemented, it will be transformative for San Antonio.

Councilmember Sandoval asked if annual reporting was a requirement contained within the PSL Ordinance. Ms. Bridger reported that she did not have that answer but would report back. Councilmember Sandoval requested that annual reporting be included in the PSL Ordinance if not within the first year, to be included each year thereafter. Councilmember Sandoval requested the PSL Procedures being developed by the Health Department. Councilmember Sandoval also suggested that

the revised Procedures be reported before the Community Health and Equity Council Committee unless the Mayor preferred a full City Council briefing.

Councilmember Cabello Havrda asked if the original PSL Ordinance contained a delayed implementation for small businesses of less than five employees. Ms. Bridger replied that was one of the major changes the PSL Commission recommended was to do away with the delayed implementation for small businesses. Councilmember Cabello Havrda asked why that was not included in the iteration discussed today. Ms. Bridger reported that the one-size fit-all approach was utilized to eliminate any reference to business size and said all businesses regardless of the number of employees shall provide up to 56 hours of safe and sick leave time off.

Councilmember Andrews-Sullivan noted that District 2 was one of the most economically-segregated areas she has grown up in. She added that the PSL Ordinance would help someone with mental health when they need a moment to handle their situation. She thanked everyone involved with the PSL Ordinance for providing a voice for those that need it. Councilmember Andrews-Sullivan requested a quiet room/meditation room in the workplace that employees can gather their thoughts. Relative to Interns, she added that interns could help relieve that burden and provide a solution to small employers.

Councilmember Perry spoke in opposition of the PSL Ordinance adding that it will have a negative impact on small businesses. He added that if an employee was not happy with their compensation or benefits, they can leave and find another job. He noted that the City should not get involved with employee and employer issues. He asked Ms. Jalisa Carrillo address the Council. Ms. Carrillo stated that she was a small minority owned business owner. She noted that she was not against sick leave or paid time off. She added that the one-size fits-all approach was wrong for San Antonio. She urged Council to consider the small businesses.

Councilmember Rocha Garcia asked how grant funded programs might be affected by PSL. Mr. Contreras reported that nonprofit entities were considered a business regardless of their funding source and would be treated the same. He noted that there may be language in federally funded grants that would supersede any local ordinance.

Councilmember Gonzales asked if after a year of employment the employee utilized PSL and the employer pays PSL properly, can the employer still terminate employment. Ms. Bridger reported that an employer can terminate employment. Councilmember Gonzales asked if the PSL Ordinance had a requirement for businesses to have a handbook to inform employees of their benefits. Ms. Bridger reported that there was not a requirement for the employer to have a handbook. Ms. Bridger added that if the employer had a handbook, they must make reference to the PSL Ordinance.

Councilmember Gonzales asked if signage was required to inform employees of the PSL Ordinance. Ms. Bridger reported that employers must post signs in their business notifying employees that they have the right to earn Paid Sick and Safe Leave. Councilmember Gonzales requested that Ms. Bridger read the language contained within the PSL Ordinance regarding the Health Departments limitations regarding investigations for the record. Ms. Bridger stated "the department shall only investigate matters related to this Article and submitted complaints related to this Article."

Councilmember Treviño noted that public trust was important and that the will of the people that gathered 144,000 Signatures truly shows the will of the people. He thanked a number of people that were instrumental in gathering signatures as well as those that served on the PSL Commission.

Councilmember Pelaez asked if the PSL Ordinance (including amendments) runs concurrently with FMLA Leave or Workers' Comp Leave. Mr. Guzman responded yes ad further explained that those Federal requirements remain in place and that the PSL Ordinance does not supersede any of those requirements.

Councilmember Viagran asked what entities are not impacted by the PSL Ordinance. Ms. Bridger reported that the Ordinance did not apply to Political Subdivisions, School Districts, the City of San Antonio, Corporations wholly owned by the Government, State Agencies, and exclusions under the Railway Labor Act.

Councilmember Viagran asked if there was a differentiation between part time, full time, or temporary employees. Ms. Bridger reported that they are all eligible to earn 56 hours of PSL.

Councilmember Courage reminded all that the people gathered 144,000 Signatures and that the Council was obligated to follow the City Charter. He added that the City followed the process by creating a Commission which spent one year reviewing data to ensure a comprehensive holistic approach was taken. He noted that there was always room for improvement which the Council would consider. Councilmember Courage thanked all involved with bringing forth revisions to the PSL Ordinance. He asked how the PSL Ordinance would affect businesses in other municipalities. Mr. Guzman reported that the PSL Ordinance did not affect employees wholly employed in other municipalities. Mr. Guzman added that if that business had employees in a San Antonio branch office, employees of that branch office would be entitled to earn PSL. Mr. Guzman added the PSL Ordinance was not proactive, meaning someone must file a complaint to trigger review of a specific situation.

Mayor Nirenberg thanked Chairwoman Hardgrove in chairing the PSL Commission and thanked the commission members in reviewing and recommending revisions to the PSL Ordinance. He added that the goal was to support public health and the quality of life.

Mr. Segovia clarified that the City's official position was as articulated in documents, pleadings, or any arguments made before the court. He added our public and legal position remains that both the original Ordinance and any Ordinance as amended, proposed amendment today, is valid and not preemptive.

Councilmember Perry moved to amend the proposed Paid Sick and Safe Leave Ordinance by excluding Small Businesses with 49 or fewer employees as defined by the Family Medical Leave Act from the requirement to provide Sick and Safe Leave and to also include language that excludes family members in calculating the number of employees for an employer. Councilmember Rocha Garcia seconded the motion. The motion failed as follows:

Councilmember Rocha Garcia moved to amend the proposed Paid Sick and Safe Leave Ordinance by excluding Small Businesses with five or fewer employees from the requirement to provide Sick and Safe

Leave and to also include language that excludes family members in calculating the number of employees for an employer. Councilmember Perry seconded the motion. The motion failed as follows:

Councilmember Rocha Garcia moved for the division regarding two areas which are transit workers and internship workers to vote on them separately. Councilmember Viagran seconded the motion. The motion failed as follows:

Councilmember Sandoval moved to recommend the revisions to Chapter 13, Article 11 Unpaid Sick Time as set out in the red lined document to the City Council with the following amendment, the definition of employee in Section 15-269 should be revised to delete reference to interns. Councilmember Treviño seconded the motion. The motion prevailed as follows:

An Ordinance authorizing the City Manager or designee to enter into a lease agreement with the Animal Defense League of Texas (ADL) to operate and manage the Paul Jolly Center for Pet Adoptions and PETCO Pavilion located at 210 Tuleta in Brackenridge Park for a one-year term with an automatic extension of two years if performance requirements are met, plus the option to renew the lease for one additional three-year term if performance requirements are met. Funding in the amount of \$475,000 for the first year of the contract is included in FY 2020 General Fund Adopted Budget. [María Villagómez, Deputy City Manager; Heber Lefgren, Director, Animal Care Services]

Mayor Nirenberg called upon the individuals registered to speak:

Joel McLellan, Executive Director of the Animal Defense League (ADL) of Texas spoke in favor of Item 18. He noted that the ADL was fortunate to have 240 medical housing spaces available to treat a wide variety of diseases. He added they have a two-prong policy for occupant management resulting in

the rehabilitation and treatment of sick or injured rescue animals.

Chelsea Payne, lead Veterinarian Manager of ADL spoke in favor of Item 18. She noted that the ADL has been able to increase the inflow and outflow of animals from the shelter by 25%. She added that they have been able to accomplish the advanced medical cases due to in-house blood work capability to include urinalysis and digital ultrasound capabilities. Ms. Payne added that their foster program has also increased by 50%.

John Bachman noted that the ADL was a wonderful organization and that 2,000 animals would be rescued at the Paul Jolly Center. He added that the 2,000 number was lower than previous years. He stated that the \$475,000 allocated to this program would be better spent spaying and neutering animals.

Mr. Heber Lefgren provided a Power Point presentation. He noted that Animal Care Services (ACS) impounded approximately 31,000 cats and dogs per year. He added that ACS built the Paul Jolly Adoption Center in 2010. He noted that the Center was located at Brackenridge Park and was operated by partners of ACS. He added that the current contract would expire at the end of October.

Councilmember Viagran moved to approve Item 18. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

Councilmember Andrews-Sullivan made a motion to approve Item 21. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek read the caption for Item 25:

#### **CONTINUED UNTIL OCTOBER 17, 2019**

25. Ordinance approving a contract with the Center for Common Concerns/HomeBase in the amount of \$128,898.00 to conduct a comprehensive Homeless Strategic Plan for the period of October 3, 2019 through September 30, 2019. Funds for this contract are included in the FY 2020 General Fund Adopted Budget. [Colleen M. Bridger, MPH, PhD, Assistant City Manager; Melody Woosley, Director, Human Services]

Ms. Woosley provided a Power Point presentation and noted that a midyear budget adjustment was made allocating \$200,000 from the Operating Contingency Fund for the assessment of the Local Homeless Response System. She added that the System includes identifying gaps in services and prioritizing improvements.

Ms. Woosley noted that an RFP for services was issued in June 2019 and proposals were evaluated in August. She added that six firms responded to the RFP and that the Evaluation Committee interviewed all six firms and unanimously scored the Center for Common Concerns dba Home Base as the highest ranking applicant. Ms. Woosley noted that Home Base was headquartered in San Francisco, California and that they have extensive experience conducting homeless plans and capacity building for homeless providers across the country.

Councilmember Perry asked if Home Base conducted homeless plans for San Francisco, Los Angeles, or Seattle. Ms. Woosley reported that those three cities were not on her list. Councilmember Perry noted that he had a problem approving funding for a company in San Francisco because San Francisco had a severe homeless problem and they are not a model to emulate.

City Manager Walsh reported that this effort was a result of City Council direction at the end of 2018 because the strategic plan had not been updated for a number of years. He added that the RFP was designed to reevaluate the environment, community partners, Haven for Hope, Non-Profits, the City, and the County to identify where the gaps are. City Manager Walsh reported that \$500,000 was set aside as a result of the .50 cent adjustment on tower and river barge rides. He added that Ms. Woosley was scheduled to report back to Council in March or April and make recommendations on where the gaps are.

Councilmember Perry asked who would be included in the Strategic Plan. Ms. Woosley reported that the effort would be led by the City and would include the South Texas Regional Alliance for Homeless. She added that they were the federally mandated continuum of care. She added that stakeholders would be engaged communitywide to include non-profits, business community, and neighborhood associations. Councilmember Perry requested a list of all entities involved and asked that the County and District Attorney's Office be included. Councilmember Perry added that homeless issues were the number one problem in District 10 and his constituents want a solution.

Councilmember Pelaez recognized District Attorney Joe Gonzales and invited him to the podium to say a few words. Mr. Gonzales reported that homelessness was a city and countywide problem that has existed for many years. He added that under the Texas Penal Code, being homeless was not a crime. Mr. Gonzales added that the homeless population frequently commits criminal trespass and that his office personally reviews each case for prosecution if necessary.

Councilmember Rocha Garcia asked if this item went through the high-profile contract process. Ms. Woosley reported no and added that the RFP was not a high-profile contract.

Councilmember Rocha Garcia made a motion to continue Item 25 until October 17, 2019. Councilmember Andrews-Sullivan seconded the motion. The motion to continue prevailed by the following vote:

**34.** City Manager's Report

City Manager Walsh reported that the National Procurement Institute (NPI) has awarded the City's Purchasing Division in the Finance Department with the prestigious 24<sup>th</sup> Annual Achievement of Excellence in Procurement (AEP) Award for 2019. He added that the AEP Award is earned by organizations that demonstrate excellence in innovation, professionalism, productivity, e-procurement, and leadership attributes of the procurement organization.

City Manager Walsh reported that TML begins next week on October 9, 2019 and over 3,000 City Officials from across Texas are registered. He added that donations of clothing, toiletries, and Halloween Costumes will be accepted and will benefit Family Violence Prevention Services and the Battered Women & Children Shelter in San Antonio.

The Mayor and City Council sang Happy Birthday to Councilmember Perry and wished him a Happy Birthday.

Mayor Nirenberg recessed the meeting until 2:55 pm.
