

AN ORDINANCE 2014 - 08 - 14 - 057 8

AUTHORIZING THE ACCEPTANCE OF A NATIONAL WILDFIRE COORDINATING GROUP TYPE III BRUSH TRUCK VALUED AT APPROXIMATELY \$85,000 FROM THE TEXAS INTRASTATE FIRE MUTUAL AID SYSTEM VEHICLE ASSIGNMENT PROGRAM.

WHEREAS, the Texas Intrastate Fire Mutual Aid System Vehicle Assignment Program has available a National Wildfire Coordinating Group type III brush truck valued at approximately \$85,000.00; and

WHEREAS, the San Antonio Fire Department (SAFD) wishes to accept said vehicle for use in supporting the SAFD Wildland Team; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee are hereby authorized to accept a National Wildfire Coordinating Group type III brush truck from the Texas Intrastate Fire Mutual Aid System Vehicle Assignment Program. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said acceptance.

SECTION 2. The acquisition of these assets shall be coordinated through the Finance Department to ensure the addition of these assets into the City's financial records and to record the proper accounting transactions.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


