AN ORDINANCE 2015 - 06 - 04 - 047 9

ACCEPTING THE LOWEST RESPONSIVE BID AND AWARDING A CONSTRUCTION CONTRACT IN THE AMOUNT NOT TO EXCEED \$808,105.00 TO E-Z BEL CONSTRUCTION, LLC FOR THE WILSON BOULEVARD (CLUB DRIVE TO DONALDSON AVENUE) & THESPIAN ISLAND, A 2012-2017 BOND-FUNDED PROJECT, LOCATED IN COUNCIL DISTRICT 7, OF THIS AMOUNT \$29,000.00 WILL BE REIMBURSED BY SAN ANTONIO WATER SYSTEMS AND \$173,290.00 WILL BE REIMBURSED BY CPS ENERGY.

WHEREAS, the 2012-2017 Bond Program General Obligation Bond Program authorized \$1,000,000.00 for the Wilson Boulevard (Club Drive to Donaldson Avenue) & Thespian Island Project, and of this amount \$605,815.00 will be used for construction with the balance of the Project funds to be used for design services, environmental services, advertising, and project management; and

WHEREAS this Project provides for street resurfacing along Wilson Boulevard (Club Drive to Donaldson Ave.), and the reconstruction of sidewalks and curbs on the west side of Wilson (Club Drive to Donaldson Avenue) and also includes the construction of a curbed center grassy median for pedestrian refuge which provides added safety for the students who cross Kampmann Boulevard going to and from Thomas Jefferson High School; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by E-Z Bel Construction, LLC in the amount not to exceed \$808,105.00 for the Wilson Boulevard (Club Drive to Donaldson Avenue) & Thespian Island Project, and

WHEREAS, of the total contract amount the City will be reimbursed \$29,000.00 by San Antonio Water Systems and \$173,290.00 will be reimbursed by CPS Energy; and

WHEREAS, this is a one-time capital improvement expenditure in the amount of \$808,105.00 for which funds are available from the 2012-2017 General Obligations Bonds and are included in the FY 2015 - 2020 Capital Improvements Program Budget; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid of **E-Z Bel Construction**, **LLC** in the amount not to exceed \$808,105.00 for the Wilson Boulevard (Club Drive to Donaldson Avenue) & Thespian Island Project is hereby accepted. All other bids will be considered rejected upon the execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever occurs first.

- SECTION 2. A construction contract is hereby awarded to E-Z Bel Construction, LLC.
- **SECTION 3.** The following financial adjustments are hereby approved:
 - a) Funds are authorized to be received from SAWS to SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00322, Wilson Blvd (Club-Donaldson) & Thespian, and the budget shall be revised by increasing WBS element 40-00322-90-08, SAWS Contribution and SAP General Ledger 4502280, Contribution from other Agencies, in the amount of \$29,000.00.
 - b) The amount of \$24,000.00 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00322, Wilson Blvd (Club-Donaldson) & Thespian, SAP WBS Element 40-00322-05-02-03, Construction-SAWS Sewer and SAP General Ledger 5201245.
 - c) The amount of \$5,000.00 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00322, Wilson Blvd (Club-Donaldson) & Thespian, SAP WBS Element 40-00322-05-02-04, Construction-SAWS Water and SAP General Ledger 5201245
 - d) Funds are authorized to be received from CPS Energy to SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00322, Wilson Blvd (Club-Donaldson) & Thespian, and the budget shall be revised by increasing WBS element 40-00322-90-09, CPS Contribution and SAP General Ledger 4502280, Contribution from other Agencies, in the amount of \$173,290.00.
 - e) The amount of \$173,290.00 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00322, Wilson Blvd (Club-Donaldson) & Thespian, SAP WBS Element 40-00322-05-02-06, Construction-CPS Gas and SAP General Ledger 5201245.
 - f) Payment in the amount of \$808,105.00 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 40-00322, Wilson Blvd (Club-Donaldson) & Thespian, is authorized to be encumbered and made payable to E-Z Bel Construction, LLC for construction services. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal

Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
