

AN ORDINANCE 2017-06-21-0483

CANVASSING THE JUNE 10, 2017 RUNOFF ELECTION RESULTS.

* * * * *

WHEREAS, the May 6, 2017 General Election resulted in the need for a runoff election for the offices of the Mayor and City Council Districts 1, 2, 6, 8, 9, and 10; and

WHEREAS, the runoff election was held on Saturday, June 10, 2017, and it is now necessary to canvass the returns of the runoff election; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council convened today at 11:30 am, to canvass the returns of the runoff election held on Saturday, June 10, 2017. Upon canvassing the returns of this election, the City Council finds and determines that this election was duly ordered; proper notice of this election was given; proper election officers were duly appointed prior to this election; the election was duly held; the City has complied with all laws governing the election; and due returns of the result of this election have been made and delivered, all in accordance with the laws and the Ordinance ordering the runoff election.

SECTION 2. The City Council does officially find and declare the results of the runoff election to be as follows:


