REQUEST:

The applicant is requesting Historic Tax Certification for the property at 822 N Pine.

APPLICABLE CITATIONS:

UDC Section 35-618. Tax Exemption Qualifications:

(d) Certification.

(1) Historic and Design Review Commission Certification. Upon receipt of the owner's sworn application the historic and design review commission shall make an investigation of the property and shall certify the facts to the city tax assessor-collector within thirty (30) days along with the historic and design review commission's documentation for recommendation of either approval or disapproval of the application for exemption.

FINDINGS:

- a. The scope of work consistent of various items that have been administratively approved including repairs to the foundation, roofing, siding, front porch and wood windows as well as mechanical, electrical and plumbing upgrades, painting and other rehabilitative tasks.
- b. The applicant has met all of the requirements for Historic Tax Certification outlined in UDC Section 35-618 and has provided evidence to that effect to the Historic Preservation Officer including interior photos and invoices.

Staff recommends approval as submitted based on findings a and b.

Scope of Work to 822 N Pine

Built around 1900, we plan to do the following improvements to redevelop the property with intent to sell. The house is being renovated into a 3/2 bath, currently a 2/1

Foundation is undergoing major repairs with over 40 concrete piers being added, along with several support beams.

Standing seam metal roof will receive a new coat/cover

Siding will be replaced where foundation crew tore out for work

Exterior will be scraped and repainted.

Windows will be repaired with broken glass replaced

Front porch repaired

Exterior landscaping

Front doors replaced

Original wood floors sanded, repaired, and stained

New Plumbing, HVAC installed, and new electrical

Insulation, new sheetrock, texture

Interior paint

4" trim throughout house

New bathrooms (existing clawfoot tub will be refinished)

New cabinets, granite, appliances in kitchen

New interior doors

All work will be done with best efforts to align to neighborhood feel and look.

We expect to be finished with renovation by October 30th, 2015.
