BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offers submitted by Cowboy Chrysler Dodge Jeep Ram and Silsbee Ford to provide the San Antonio Police Department with four vehicles for use in the department's program used to target aggressive drivers for a total cost of \$93,484.68 are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. A copy of the contract is attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding in the amount of \$93,484.68 for this ordinance is available in Fund 72001000, Cost Center 3503200001 and General Ledger 5501055, as part of the Fiscal Year 2015 Budget.

SECTION 3. Payment not to exceed the budgeted amount of \$47,990.00 is authorized to Cowboy Chrysler Dodge Jeep Ram and should be encumbered with a purchase order.

SECTION 4. Payment not to exceed the budgeted amount of \$45,494.68 is authorized Silsbee Ford and should be encumbered with a purchase order.
