This Certificate of Exemption is executed and filed with the Finance Department as follows:

1. The undersigned is authorized to approve an exemption.
2. An exemption according to Section 252.022 of the Local Government Code exists. More specifically, the following event has occurred:

The Police Labor Relations Committee has changed its Aggressive Driving Prevention program vehicle from Ford Mustang to Ford Interceptor Sedan, which is not available on a co-operative agreement after 10/31/2018. The Ford sedan equivalent on co-operative is a hybrid-petrol rated sedan that was not approved by BAPD when presented in FY 2018.

These vehicles are planned to blend in traffic and intentionally be different than the current patrol vehicle silhouette to meet Aggressive Driving Prevention goals. The vehicle selection process would have to start over again with the Labor Relations Committee should this exemption not be approved.

3. Because the exemption stated above exists, the City of San Antonio intends to contract with Any Ford Dealer which will cost approximately \$ 177,769.00
