A RESOLUTION

IN SUPPORT OF BRISTOL POINTE FOR THE 2015 COMPETITIVE 9% HOUSING TAX CREDIT APPLICATION PROCESS AS REQUIRED BY THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS.

WHEREAS, Wolfpack Group, LLC, a Texas limited liability corporation (the “Applicant”), has proposed an 102 unit multi-family rental housing development to be located in the southwest quadrant of Overlook Parkway and Highway 281 named Bristol Pointe (the “Development”), in the Extraterritorial Jurisdiction of the City of San Antonio, County of Bexar; and

WHEREAS, the Applicant intends to submit an application to the Texas Department of Housing and Community Affairs (TDHCA) for 2015 Competitive 9% Housing Tax Credits for Bristol Pointe; and

WHEREAS, the Development will include dwelling units subsidized through the TDHCA Housing Tax Credit Program, which will provide housing opportunities for seniors with a mixture of incomes; and

WHEREAS, the developer of the Development has prepared an application to the State of Texas for Low-Income Housing Tax Credits to receive assistance in financing the construction of the Project; and

WHEREAS, the City of San Antonio has determined there is a need for additional affordable housing units for low income seniors in the proposed Development location and has reviewed a market study which supports this determination; **NOW THEREFORE:**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City of San Antonio, County of Bexar, acting through its governing body, hereby confirms that it supports the proposed Bristol Pointe to be located in the southwest quadrant of Overlook Parkway and Highway 281, TDHCA #15225, and that this formal action has been taken to put on record the opinion expressed by the City of San Antonio on February ____, 2015.

SECTION 2. The City of San Antonio hereby supports the proposed Bristol Pointe (the “Development”) and confirms that its governing body has voted specifically to approve the construction of the Development and to authorize an allocation of Housing Tax Credits for the Development.

SECTION 3. The governing body of the City of San Antonio hereby identifies Bristol Pointe, TDHCA #15225 as the Development in the 2015 competitive tax credit application round that contributes “most significantly to the concerted revitalization efforts” of the City of San Antonio.

SECTION 4. For and on behalf of City Council, the City Clerk is hereby authorized, empowered, and directed to certify this resolution to the Texas Department of Housing and Community Affairs.

SECTION 5. This Resolution is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
