**A RESOLUTION RECOMMENDING APPROVAL OF A STREET NAME CHANGE REQUEST TO CHANGE “VERANO PARKWAY” TO “JAGUAR” BETWEEN S ZARZAMORA AND MISSOURI PACIFIC RAILROAD CO. IN CITY COUNCIL DISTRICTS 3 & 4, SAN ANTONIO, TEXAS.**

**WHEREAS**, the Development Services Department staff received a Street Name Application from Texas A&M, San Antonio to change the name of “Verano Parkway” to “Jaguar Parkway”; and

**WHEREAS**, to honor Texas A&M, San Antonio’s University’s mascot, by increasing enthusiasm within the student body and develop a permanent presence within the community in the San Antonio area; and

**WHEREAS**, Chapter 6 of the City Code of San Antonio, Texas, requires street name change requests to be considered by the Planning Commission of the City of San Antonio and its recommendation forwarded to the City Council; and

**WHEREAS**, the City of San Antonio Development Services Department in accordance with Chapter 6 of the City Code of San Antonio, Texas, notified all property owners of real property along the segment of the street proposed for the name change; and

**WHEREAS**, the Planning Commission of the City of San Antonio held a public hearing on July 11, 2018, where they reviewed evidence and received public testimony regarding the proposed street name change;

**NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF SAN ANTONIO THAT:**

**SECTION 1:** The Planning Commission of the City of San Antonio recommends **APPROVAL** of the proposed street name change from “Verano Parkway” to “Jaguar Parkway”, between S Zarzamora and Missouri Pacific Railroad Co. in City Council Districts 3 & 4 (**Exhibit “A”**).


