

AN ORDINANCE 2018-08-30-0671

TERMINATING INACTIVE CAMPAIGN TREASURER APPOINTMENTS FILED WITH THE OFFICE OF THE CITY CLERK.

* * * * *

WHEREAS, the City Code, Chapter 2, Article VII, entitled "Municipal Campaign Finance Regulations", established procedures by which the City Council can terminate inactive campaign treasurer appointments of candidates and specific action political action committees; and

WHEREAS, Section 2-311 provides that a candidate or a political action committee becomes inactive if the candidate or committee has filed a campaign treasurer appointment with the Office of the City Clerk and more than one year has lapsed since the candidate or committee has filed any required campaign finance reports with the Office of the City Clerk; and

WHEREAS, in accordance with Section 2-311 and 2-312 of the City Code the Office of the City Clerk has issued letters to the treasurers of inactive campaign appointments giving notice of the intent of the City Council to terminate inactive appointments at the City Council meeting scheduled on Thursday, August 30, 2018; **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. In accordance with Sections 2-311 and 2-312 of the City Code, the campaign treasurer appointments listed in Exhibit A, attached to this Ordinance, are terminated.

SECTION 2. This ordinance is effective immediately after passage upon the receipt of eight affirmative votes, or, in the event eight affirmative votes are not received, ten days after passage.




