

AN ORDINANCE 2017-06-15-0454

AN ORDINANCE AUTHORIZING AN EXTENSION OF A PROFESSIONAL SERVICES CONTRACT WITH VHS SAN ANTONIO IMAGING PARTNERS L.P., DBA BAPTIST M&S IMAGING, TO PROVIDE MEDICAL IMAGING SERVICES FOR THE SAN ANTONIO FIRE DEPARTMENT WELLNESS CENTER FOR A ONE-YEAR PERIOD BEGINNING JANUARY 1, 2018 IN AN AMOUNT NOT TO EXCEED \$60,000.00.

WHEREAS, the City entered into a contract with VHS San Antonio Imaging Partners L.P. DBA Baptist M&S Imaging to provide medical imaging services; and

WHEREAS, the parties wish to exercise the Second Extension of the contract beginning January 1, 2018 through December 31, 2018; and

WHEREAS, the cost for the Contract Extension is an estimated annual amount not to exceed \$60,000.00;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1: The Contract Extension with VHS San Antonio Imaging Partners L.P., DBA Baptist M&S Imaging, to provide medical imaging services for the uniformed employees of the San Antonio Fire Department as part of the Wellness Program for the period from January 1, 2018 through December 31, 2018, for an estimated annual cost not to exceed \$60,000.00 is hereby approved. A copy of the Contract Extension is attached hereto and incorporated herein as Exhibit A. The terms of the Contract Extension are hereby approved. The City Manager, or her designee, is hereby authorized to execute the Contract Extension.

SECTION 2: The amount up to \$60,000.00 will be encumbered upon issuance of purchase orders, and payment is authorized to VHS San Antonio Imaging Partners L.P. dba Baptist M&S Imaging. All expenditures will be in accordance with the Fiscal Year 2018 and 2019.


SECTION 3: The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon passage by eight (8) affirmative votes; otherwise this Ordinance shall be effective on the tenth day after passage.

**SECOND EXTENSION
PROFESSIONAL SERVICES CONTRACT
VHS SAN ANTONIO IMAGING PARTNERS L.P.**

This Extension of the Professional Services Contract for medical staff at the San Antonio Fire Department Wellness Center (the "Contract") is entered into by and between the City of San Antonio ("City") and VHS San Antonio Imaging Partners L.P., DBA Baptist M&S Imaging is as follows:

WHEREAS, through Ordinance No. 2010-12-16-1101, passed and approved on December 16, 2010, City Council authorized the execution of a five-year Contract with VHS San Antonio Imaging Partners L.P., to provide chest x-rays and provided for two, one-year extensions at the City's option (the "Original Contract"); and

WHEREAS, the Original Contract provided for an initial term beginning upon signing and ending on December 30, 2016; and

WHEREAS, through Ordinance No. 2016-11-10-0896 the City exercised its option for the first renewal option to extend the Original Contract for a one-year period beginning on January 1, 2017 and ending December 31, 2017; and

WHEREAS, the City now wishes to exercise the first renewal option to extend the Original Contract for a one-year period beginning on January 1, 2018, and ending December 31, 2018;
NOW, THEREFORE:

I. RENEWAL AND EXTENSION

The City hereby exercises its option to renew and extend the term of the Original Contract for an additional one (1) year period, commencing on January 1, 2018 and terminating December 31, 2018, such option having been granted to the City in Section VI, "TERM", in Section 6.1 of the PROFESSIONAL SERVICES CONTRACT.

II. PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the Original Contract, approved by Ordinance No. 2010-12-16-1101, not specifically mentioned herein and revised by this document, are hereby retained in their entirety, unchanged, and shall remain in full force in effect for the duration of said Original Contract.
