
# ANNUAL REPORT CITIZEN BOND OVERSIGHT COMMISSION



### **2007 & 2012 Bond Programs**

## A Letter from Chair Ken Thomas

To Mayor and City Council:

This past year we have seen a tremendous amount of progress and commitment by the City of San Antonio and Transportation & Capital Improvements Department (TCI). The Commission and I would like to congratulate and thank City Manager Sheryl Sculley and Deputy City Manager, Peter Zanoni for their continued leadership on the Bond Programs. We would also like to extend our congratulations to Mike Frisbie, TCI Director and his staff for their exceptional work on the very successful 2007-2012 Bond Program and for their hard work and dedication to-date on the 2012-2017 Bond Program.

This year is also a chance to reflect on changes for the Citizen Bond Oversight Commission (CBOC). Earlier this year we lost a good friend, CBOC Member, and Vice Chair of the Animal Care Services Advisory Board, Randy Murdock. Randy's love and passion for animals led him down a life-long career path of becoming an advocate for homeless animals. In October 2013, the new Animal Care Adoption Spay/Neuter and Educational Facility located at 210 Tuleta (near Brackenridge Park) was finished. This facility provides low-cost vaccinations, low-cost spay/neutering, adoption services and community education services. To commemorate Randy's hard work and dedication, a hand-painted mural called the "Randy Murdock Giving Tree" is on an interior wall of the facility. The workers and visitors to the center will always be able to remember the dedication and love Randy had for animals.

Our second announcement is to recognize our new members to the Citizen Bond Oversight Commission: Arthur Downey and Nicholas Guinn. We welcome these new members and look forward to the future effort together.

The Commission continues to focus our efforts on communication and accountability to the public. Regular quarterly meetings hosted by TCI and provide the most recent update on the 2007 and 2012 Bond Programs. The web-based Dashboard is used as a transparent tool to ensure accountability with the public. The Dashboard is updated monthly showing the current status of the Bond Program, funds spent to-date, and status of each project.

#### 2007-2012 Bond Program:

Of the 150 projects, 147 were completed within budget. This shows the success that TCI has had in working

with their client departments and private sector, design consultants and construction contractors. The final stages of construction remain for three projects, with one to be complete by November 2014 and the remaining two to be complete by February 2015. These final projects are within budget. One of the three projects would have been completed sooner; however, the contractor defaulted on the project. Immediately following and to minimize the delay, TCI worked diligently with the bonding company who hired a new contractor to complete the project. With the 2007 Bond coming to an end, we have been focusing on the 2012-2017 Bond Program.



#### 2012-2017 Bond Program:

With lessons learned from the 2007 Bond Program, the City is even more equipped to ensure the 2012-

2017 Bond is successful. Soon after voters approved the new bond, TCI moved forward with a mass selection of Design Engineers, Architects and Landscape Architects for City Council review in October 2012. The mass selection process significantly reduced the total number of City Council actions to be processed and allowed staff to begin working with the selected firms sooner. Staff's goal of exceeding the stellar SBEDA marks achieved in the 2007 Bond Program is being realized in the 2012 Bond Program. To-date the total percentage contracted for each small business category well exceeds the benchmarks set in the 2007 Bond for participation. Additionally, TCI worked with the local utility companies (CPS/SAWS) to combine and joint-bid most of the street proposition projects which consolidated efforts and minimized the impact to the public.




Within the past year, the Commission has continued our role as advocates on behalf of the citizens of San Antonio. We have received regular briefings from Mike Frisbie on the completion of the 2007 Bond Program and progress reports on the 2012-2017 Bond Program, which is well underway. As of today, TCI has eleven (14) projects that are complete 26 under construction, 80 under design, 19 funding agreements and 1 in pre-design.




