AN ORDINANCE

**AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING
UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED
ANNUAL COST OF \$2,085,000.00: (A) RUSH AMERICAN PRINTING,
INC., TL ABBOTT INVESTMENTS, LLC AND SMITH PRINT II FOR
SUPPLEMENTAL PRINTING SERVICES, (B) POPPE AUTOMOTIVE
WAREHOUSE, INC. FOR AUTO LIGHT DUTY TRUCK DRUMS AND
BRAKE PARTS, (C) COLOR SPOT NURSERIES FOR BEDDING
PLANTS, (D) ICL PERFORMANCE PRODUCTS, LP FOR PHOS-CHEK
FOAM FOR THE SAN ANTONIO FIRE DEPARTMENT, (E) WAGNER
AUTOMATION, INC. FOR MAGNETIC OPERATORS AND GATE
INSTALLATION, PREVENTIVE MAINTENANCE, REPAIRS AND
PARTS FOR THE SAN ANTONIO INTERNATIONAL AIRPORT, AND
(F) DOGGETT FREIGHTLINER OF SOUTH TEXAS FOR CUMMINS
ISL G COMPRESSED NATURAL GAS ENGINE PARTS AND
SERVICE, AND (G) METRO FIRE APPARATUS SPECIALISTS, INC.
FOR SCBA REPLACEMENT PARTS.**

WHEREAS, bids were submitted to provide the City of San Antonio with commodities and services on an annual basis for the terms of the contracts; and

WHEREAS, these bids are from the following companies to furnish the City with: (A) Rush American Printing, Inc. (Categories A, B, D, and J), TL Abbott Investments, LLC (Categories C, F, and H) and Smith Print II (Category G) for supplemental printing services, (B) Poppe Automotive Warehouse, Inc. for auto light duty truck drums and brake parts, (C) Color Spot Nurseries for bedding plants, (D) ICL Performance Products, LP for Phos-Chek foam for the San Antonio Fire Department, (E) Wagner Automation, Inc. for magnetic operators and gate installation, preventive maintenance, repairs and parts for the San Antonio International Airport, (F) Doggett Freightliner of South Texas for Cummins ISL G compressed natural gas engine parts and service, and (G) Metro Fire Apparatus Specialists, Inc. for self-contained breathing apparatus (SCBA) replacement parts; and

WHEREAS, the bids submitted by Litho Press Inc. (Categories A, B, and F), 1st Source Digital (Categories H and J), Smith Print II (Category F), TL Abbott Investments, LLC (Category J), Thompson Print Solutions (Categories A-D, F, H, and J), Resource Printing Services (Categories G and J), Resource Printing Services Alternate Bid 1 (Category F) and Resource Printing Services Alternate Bid 2 (Category F) failed to meet the City's specifications and/or requirements for supplemental printing services; and

WHEREAS, the bids submitted by North Park Lincoln, O'Reilly Automotive Enterprises LLC, and Westway Ford failed to meet the City's specifications and/or requirements for auto light duty truck drums and brake parts; and

WHEREAS, according to section 252.022(a)(2) of the Texas Local Government Code competitive bidding is not required for a procurement of items necessary to preserve or protect the public health or safety of the municipality's residents; and

WHEREAS, this ordinance approves four contracts on the basis of low qualifying bid, three low bid contracts and two contracts procured on the basis of the public health or safety exemption; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bids from the following companies to furnish the City with: (A) Rush American Printing, Inc. (Categories A, B, D, and J), TL Abbott Investments, LLC (Categories C, F, and H) and Smith Print II (Category G) for supplemental printing services, (B) Poppe Automotive Warehouse, Inc. for auto light duty truck drums and brake parts, (C) Color Spot Nurseries for bedding plants, (D) ICL Performance Products, LP for Phos-Chek foam for the San Antonio Fire Department, (E) Wagner Automation, Inc. for magnetic operators and gate installation, preventive maintenance, repairs and parts for the San Antonio International Airport, (F) Doggett Freightliner of South Texas for Cummins ISL G compressed natural gas engine parts and service, and (G) Metro Fire Apparatus Specialists, Inc. for SCBA replacement parts. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. It has been found and declared that the bids submitted by Litho Press Inc. (Categories A, B, and F), 1st Source Digital (Categories H and J), Smith Print II (Category F), TL Abbott Investments, LLC (Category J), Thompson Print Solutions (Categories A-D, F, H, and J), Resource Printing Services (Categories G and J), Resource Printing Services Alternate Bid 1 (Category F) and Resource Printing Services Alternate Bid 2 (Category F) failed to meet the City's specifications and/or requirements.

SECTION 3. It has been found and declared that the bids submitted by North Park Lincoln, O'Reilly Automotive Enterprises LLC, and Westway Ford failed to meet the City's specifications and/or requirements.

SECTION 4. Funds will be encumbered upon issuance of purchase orders and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2016 budget and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.
