
This Proposal is offered as set forth in the terms and conditions of the contract and the

- 2. As a Joint Scope in accordance with current industry standards, OSHA Safety compliance and all governing code requirements.
- 3. No other related work requirements are acknowledged.


Assumptions & Clarifications:

- 1. We will excavate 2 access holes to tunnel under building approx. 125 LF
- 2. We will provide confined space safety procedures along with engineering for the excavation .



- 3. We will remove all existing sewer waste lines for the 2 RR and the sewer line to the water fountain in the hallway
- 4. We will load and haul off all spoils
- 5. We will demo the 2 toilets in the women's, the toilet and the urinal in the Men's and we will demo the floor drains in each R/R
- 6. We will demo the lavatory drains and faucets and replace.
- 7. We will provide new wall carriers for the toilets and urinal.
- 8. We will provide new wall carriers for the toilets and the urinal.
- 9. We will provide all new PVC sewer lines to all fixtures and floor drains for each R/R and the hallway water fountain
- 10. We will demo the ceramic tile, GWB, and framing to allow for the new plumbing work
- We will provide new metal studs, tile backer board and new ceramic tile after fixture rough in and carriers are installed and inspected. <u>Ceramic tile color will not match</u> <u>exactly.</u>
- 12. We will provide new flush valves for the new fixtures
- 13. We will provide new trap primers t each floor drain.
- 14. We will provide new carrier for drinking fountain.
- 15. Work to be performed during normal business hours.

No other work to be performed other than stated above in Assumptions & Clarifications 1 thru 15
