

**AN ORDINANCE 2016-05-05-0320**

**APPOINTING PAMELA E. RAY (CITY COUNCIL DISTRICT 2), RICHARD PEREZ (CITY COUNCIL DISTRICT 4), LUCY HALL (CITY COUNCIL DISTRICT 6), DR. SHARI ALBRIGHT (CITY COUNCIL DISTRICT 8), AND PHILLIP THOMSON (CITY COUNCIL DISTRICT 10) TO THE BOARD OF DIRECTORS FOR THE CITY OF SAN ANTONIO'S EARLY CHILDHOOD EDUCATION MUNICIPAL DEVELOPMENT CORPORATION FOR TWO YEAR TERMS BEGINNING JUNE 1, 2016 AND ENDING MAY 31, 2018.**

**WHEREAS**, Chapter 379A, Texas Local Government Code (the "Act") authorizes a municipality to create a municipal development corporation to develop and implement programs for early childhood development that prepare each child to enter school and make each child ready to learn after completing the program, that provide educational services to promote literacy, and that establish math, reading, and lifelong learning skills; and

**WHEREAS**, the City Council (the "City Council") of the City of San Antonio, Texas (the "City") authorized the creation of the San Antonio Early Childhood Education Municipal Development Corporation (the "Corporation") for the purposes of developing early childhood literacy and educational programs in accordance with the Act; and

**WHEREAS**, pursuant to the Act, the City called a sales tax election, held on November 6, 2012, for voter approval to levy a sales and use tax for the benefit of the Corporation; and

**WHEREAS**, the voters approved the imposition of a 1/8 cent sales tax, and the City Council has passed an ordinance adopting and imposing such tax on December 13, 2012; and

**WHEREAS**, the Act requires the City Council to appoint one director to the Board of Directors for the Corporation from each city council district that elects a member to the City Council, plus the Mayor; and

**WHEREAS**, the Act requires that the initial terms for Board members be staggered so that as near as possible to one-half of the member's terms expire each year, thus members appointed from odd-numbered districts, as well as the Mayor's appointee, serve terms expiring in odd-numbered years, and members appointed from even-numbered districts serve terms expiring in even-numbered years; and

**WHEREAS**, City Council members for even-numbered districts hereby make their appointments for Board members for the Corporation with terms beginning June 1, 2016 and ending May 31, 2018; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Pamela E. Ray (District 2), Richard Perez (District 4), Lucy Hall (District 6), Dr. Shari Albright (District 8), and Phillip Thomson (District 10) are appointed to the Board of Directors for the City of San Antonio's Early Childhood Education Municipal Development Corporation, for terms of office beginning on June 1, 2014 and expiring on May 31, 2016.

**SECTION 2.** This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
