

RESOLUTION NO. **2015-01-29-0006R**

**RESOLUTION APPROVING A FINANCING BY THE NEW HOPE CULTURAL EDUCATION FACILITIES FINANCE CORPORATION OF HEALTH FACILITIES LOCATED WITHIN THE CITY OF SAN ANTONIO, TEXAS FOR GLEN HOPE HARBOR, INC. FOR PURPOSES OF SECTION 147(f) OF THE INTERNAL REVENUE CODE**

**WHEREAS**, the Cultural Education Facilities Finance Corporation Act, 1528m, V.A.T.C.S., (the "Act"), authorizes and empowers New Hope Cultural Education Facilities Finance Corporation (the "Issuer") to issue revenue bonds or notes on behalf of the Town of New Hope, Texas (the "Issuing Unit") to finance the costs of health facilities found by the Board of Directors of the Issuer to be required, necessary or convenient for health care, research and education, any one or more, within the State of Texas and in furtherance of the public purposes of the Act; and

**WHEREAS**, Glen Hope Harbor, Inc. (the "Borrower"), a Texas nonprofit corporation and 501(c)(3) organization, proposes to obtain financing from the Issuer from the proceeds of one or more series of the Issuer's bonds or notes in a maximum principal amount of \$45,000,000 (the "Bonds") to finance the acquisition of nine assisted living facilities, each of which contains approximately 6,300 to 7,500 square feet and includes 16 units, congregate living and dining areas, a central kitchen and related common areas, with two facilities being located at 1418 Walkers Way, San Antonio, Texas 78216 and 20718 Stone Parkway, San Antonio, Texas 78258 (collectively, the "Project"); and

**WHEREAS**, Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code") requires that the bonds or notes and the facilities to be financed with the bonds or notes be approved by the governmental unit or the highest elected official of the governmental unit having jurisdiction over the area in which the facilities will be located after the holding of a public hearing relating to the bonds or notes and the facilities; and

**WHEREAS**, the Project is located within the City of San Antonio, Texas (the "City") and outside the limits of the Issuing Unit;

**WHEREAS**, the City Council, as an "applicable elected representative" of the City, has been requested to approve the issuance of the Bonds and the Project solely for purpose of complying with the requirements of Section 147(f) of the Code, and has been furnished with an affidavit of publication of notice of such hearing, which was published in a newspaper of general circulation available to residents within the boundaries of the City, and minutes of the public hearing conducted on November 17, 2014, in connection therewith; and

**WHEREAS**, the actions of the Issuer with respect to the Project and the Bonds and the action of the City Council with respect to the matters described herein will create no liability for the City and the City Council desires to hereby approve the issuance of the Bonds and the Project solely for the purpose of satisfying the requirements of Section 147(f) of the Code; ***NOW THEREFORE:***

***BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO, TEXAS:***

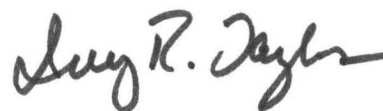
Section 1. The City Council hereby approves the issuance of the Bonds and the Project for the limited purposes stated herein.

Section 2. The authorization and approval of the Bonds and the Project is made for the sole purpose of satisfying the requirements of Section 147(f) of the Code, and for no other purpose and shall not be construed as a representation, warranty or other undertaking of any kind by the City or the City Council in respect of the Bonds or the Project. The Bonds shall not constitute obligations of the City or a pledge of its faith and credit, and the City shall not be obligated to pay the Bonds or the interest thereon or otherwise incur any liability in respect thereof.

Section 3. The Mayor and City Secretary of the City and other officers of the City are hereby authorized to execute and deliver such instruments, certificates or documents necessary or advisable to carry out the intent and purpose of this Resolution.

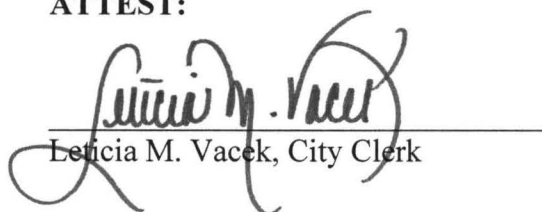
Section 4. This Resolution shall take effect immediately upon its passage and shall continue in force and effect from the date hereof.

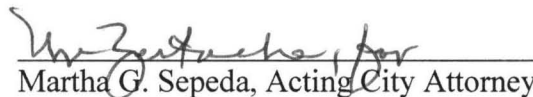
