AN ORDINANCE

**AUTHORIZING THE THIRD AMENDMENT TO THE AUTOMATED
TELLER MACHINE LICENSE AGREEMENT WITH CARDTRONICS
USA, INC. TO PROVIDE FOR ATM SERVICES AT NINE LOCATIONS
THROUGHOUT THE CITY FOR A FIVE (5) YEAR TERM ENDING
SEPTEMBER 30, 2019, WITH ONE FIVE (5) YEAR RENEWAL OPTION.**

WHEREAS, a Request For Proposals (“RFP”) was issued by City Staff on December 20, 2013; and

WHEREAS, the RFP sought proposals to provide ATM services at specified locations throughout the City that will be serviced by the current contractor through July 31, 2014; and

WHEREAS, one Proposal was received in response to the RFP, and it was deemed non-responsive by City Staff, and the RFP was cancelled; and

WHEREAS, the City has an existing contract with CARDTRONICS USA, INC. (“Cardtronics”), pursuant to which Cardtronics provides ATM services at the Alamodome; and

WHEREAS, Cardtronics is willing to provide ATM services at nine (9) locations throughout the City other than the Alamodome (“Additional Locations”) that will be serviced by the prior contractor through July 31, 2014; and

WHEREAS, City Staff recommends amendment of the existing contract with Cardtronics to include the provision of ATM services at the Additional Locations for a five (5) year term ending September 30, 2019, with one (1) five (5) year renewal term; and

WHEREAS, the City Council, upon consideration of and deliberation on such recommendation, desires to accept City Staff’s recommendation; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of the *Third Amendment To Automated Teller Machine License Agreement* (“Third Amendment”) with Cardtronics for an initial five (5) year term ending September 30, 2019, with one (1) five year renewal term, are hereby approved.

The City Manager, or her designee, or the Chief Financial Officer or his designee, or the Director of Finance, or his designee, is hereby authorized to enter into and execute the Third Amendment, under terms and conditions substantially in accordance with those set forth in **Attachment I** to this Ordinance.
