

AN ORDINANCE **2017-03-30-0185**

ABOLISHING THE CONVENTION AND VISITORS COMMISSION AND THE COMMUNITY DEVELOPMENT ADVISORY COMMITTEE; AND REPEALING THE ORDINANCES ESTABLISHING AND APPOINTING MEMBERS TO THE RESPECTIVE BODIES.

WHEREAS, in accordance with Chapter 2, Article IX, Section 2-542 of the City Code of the City of San Antonio, the mayor appointed a three-member ad hoc advisory committee to review the annual reports of District Boards, Commissions and Committees, and to recommend reauthorization or sunset of inactive boards, commissions and committees to the Governance Committee and then to the full Council; and

WHEREAS, the City established "Visit San Antonio" in 2016, which has an oversight board performing the function of the City's Convention and Visitors Commission, rendering it moot; and

WHEREAS, the Community Development Advisory Committee was created in 2008 to propose policy changes regarding community development, and provide recommendations to City Council regarding the implementation of the 2008-2009 Strategic Plan for Community Development, and it has been superseded by other City Council created boards and commissions with updated missions, such as the Mayor's Commission on Preserving Dynamic and Diverse Neighborhoods; and

WHEREAS, the Governance Committee met on January 18, 2017, concurred with the recommendations of the ad hoc subcommittee that the two boards above should be sunset; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Ordinances creating the Convention and Visitors Commission and the Community Development Advisory Committee are repealed, and the Commission and Committee are abolished.

SECTION 2. All Ordinances and Minute Orders appointing members to the Commission and Committee are repealed.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight affirmative votes, or in the event eight affirmative votes are not received, ten days after passage.
