The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

1. The Invocation was delivered by Pastor Randall L. Bales, University Baptist Church, guest of Councilmember Manny Pelaez, District 8.
2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.
3. Approval of Minutes for the City Council Regular Meetings of April 18 - 19, 2018.

Councilmember Saldaña moved to approve the Minutes for the City Council Regular Meetings of April 18-19, 2018. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

**POINTS OF PERSONAL PRIVILEGE**

Mayor Nirenberg recognized Outgoing Brigadier General Heather Pringle and commended her on her many accomplishments. Brigadier General Pringle thanked the City Council for the recognition and stated that she had enjoyed being part of the San Antonio Community. The City Council wished Brigadier General Pringle well in her future endeavors.

Mayor Nirenberg recognized Jeff Coyle, Director of the Government and Public Affairs Office. Mr. Coyle presented the Legislator of the Year Award from the Texas Mayors of Military Community to State Representative, Roland Gutierrez. Representative Gutierrez stated that he was honored to accept the award and thanked the City Council for the recognition. Mayor Nirenberg and the City Council congratulated Representative Gutierrez on the award.

Councilmember Pelaez thanked the Methodist Healthcare System of San Antonio for their expansion into District 8 which will lead to additional investment and 200 new jobs (Item 16). He also welcomed Rawlinson Middle School Students and their Teacher, Angela Lewis, and highlighted the "Espresso Yourself" Program dedicated to preparing Special Education Students for High School. Mayor Nirenberg and the City Council welcomed them to the meeting.

**INDIVIDUAL ITEM FOR STAFF BRIEFING**

City Clerk Vacek read the caption for Item 4:

4. Report on the results of the examination of signatures on the three Petitions submitted to amend the City Charter. [Leticia M. Vacek, City Clerk]

City Clerk Leticia Vacek presented a report on the Three Petitions to Amend the City Charter submitted to the Office of the City Clerk. She reported that on April 11, 2018, she received Three Petitions seeking to amend the City Charter as follows:

Petition 1: "Petition for a City of San Antonio Charter Amendment to Set a Limit on the Appointment, Term of Appointment, and Salary of a City Manager."

Petition 2: "Petition for a City of San Antonio Charter Amendment to Facilitate Voter Use of the Referendum Process."

Petition 3: "Petition for a City of San Antonio Charter Amendment to Require Arbitration, in Lieu of Litigation, in the Event of Impasse in Collective Bargaining."

Mrs. Vacek stated that the Office of the City Clerk had utilized the Bexar County Elections Office Votec Elections Management And Compliance System (VEMACS) to verify the signatures. She noted that VEMACS was programmed in accordance with provisions outlined in Chapter 277 of the Texas Election Code. She added that VEMACS allows users to search by Voter Identification Number, Name, Address, or Date of Birth, as well as providing for signature verification.

Mrs. Vacek presented the number of signatures verified for each petition. She stated that per Section 37 of the City Charter and Section 9.004 of the Local Government Code; each paper of the three petitions had a proper statement of the circulator and were signed by a sufficient number of qualified electors. She certified the results of her examination of each of the Three Petitions Submitted to Amend the City Charter as valid. She noted that the City Council had until August 20, 2018 to call a Special Election for the November 6, 2018 Ballot.

Mayor Nirenberg called upon Mr. Jack M. Finger to speak.

Jack M. Finger stated that many people had signed the petitions as they wanted their voice heard.

Councilmember Gonzales asked of the verification process. Mrs. Vacek replied that it was set by Chapter 277 of the Texas Election Code and required verification of the signer's date of birth, address, and signature. Councilmember Gonzales asked of the language presented in the petition. Andy Segovia replied that unless the language was negotiated; it would appear on the ballot as it was submitted on each petition.

Councilmember Brockhouse stated that the City Council's role was ministerial and that the three items should be placed on the ballot.

Councilmember Courage expressed concern that many of the petitioners were not well-informed about what they were signing.

Councilmember Pelaez recognized Mrs. Vacek and staff for their great work in verifying the significant amount of petitions in a short amount of time.

Mayor Nirenberg stated that he could not remain agnostic when people attempt to hurt the city and expressed concern with the motivation behind the petitions.

No action was required for Item 4.

Councilmember Courage asked if the equipment had the capability to broadcast live off-site. Jeff Coyle replied that it did. He confirmed that city staff would manage the equipment and that City Council Offices and staff could utilize it. Councilmember Courage asked of the funding. Mr. Coyle replied that they were using Public, Education, and Government (PEG) Funds to purchase the equipment.

Councilmember Sandoval asked if the equipment would be used to broadcast online, on TVSA, or both. Mr. Coyle stated that they would try to use both mediums and that it would

be available within one month.

Councilmember Courage moved to adopt the Ordinance for Item 5. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

Razi Hosseini presented information on the Broadway Street Corridor Project highlighting the project scope and benefits. He provided an overview on the Design-Build Selection Process and noted that Sundt Construction had a 128-year history of roadway construction. He added that staff recommended approval to execute a \$32.7 million Design-Build Services Agreement with Sundt Construction, Inc.

Mayor Nirenberg called upon Mr. David Adelman to speak.

David Adelman spoke in support of the project and noted that they had formed a stakeholder group that would continue to work with city staff to deliver an excellent project.

Councilmember Treviño thanked everyone that worked on the project that would transform the Broadway Corridor and help form other corridors in the future. Councilmember Sandoval expressed her support and stated that she looked forward to seeing the finished product.

Councilmember Courage moved to adopt the Ordinance for Item 7. Councilmember Courage seconded the motion. The motion prevailed by the following vote:

Razi Hosseini presented an overview of 2017 Bond Pedestrian Mobility Packages #2 and #5 highlighting the project scope and benefits. He noted that construction would begin in June 2018 and be completed in November 2019. He added that staff recommended approval to award Task Order Package #2 to San Antonio Concepts Construction and Task Order Package #5 to Pinnacle Concrete Construction, LLC.

Councilmember Gonzales stated that she was pleased with the city's direction in making streets more pedestrian friendly and highlighted the pedestrian mobility items within the projects.

Councilmember Courage requested a timeline for projects noting that there were several in District 9 and he would like to know when they would be online.

Councilmember Pelaez requested that the projects be presented to the City Bond Oversight Committee. Mike Frisbie confirmed that they would.

Councilmember Perry expressed concern that District 10 did not receive any funding for Pedestrian Mobility.

Councilmember Gonzales moved to adopt the Ordinances for Items 9A and 9B. Councilmember Shaw seconded the motion. The motion to approve Items 9A and 9B prevailed by the following vote:

Michael Shannon presented information regarding the renaming of "North Rio Grande" and "South Rio Grande" to "N Mel Waiters Way" and "S Mel Waiters Way". He stated that

they followed the process in accordance with Chapter 6 of the City Code and highlighted the Address Changes, Notice to Owners, Neighborhood Associations, and Technical Review Agency Coordination.

Mayor Nirenberg called upon the citizens registered to speak.

Gloria Walker spoke in opposition to the name change noting that there were other individuals that deserved the recognition.

Laura Mills stated that she was opposed to the renaming due to the financial burden it would have on those affected.

Jeanette De La Luz spoke in opposition to the request due to the negative effect it would have on her and her family.

Joseph Olier stated that he was opposed to the name change and felt a “Memorial Way” designation may be a better option.

A group of 26 individuals led by Brittany and Courtney Waiters addressed the City Council in support of the request. Brittany spoke of the work of her father Mel Waiters and the great impact he had on the community. She stated that they had followed the process and requested approval from the City Council. TC Calvert stated that he was representing the Neighborhoods First Alliance and they had gone door-to-door and many businesses and residents were supportive of the request. Rosie Baca stated that she was a resident of the area and supportive of the request. Mercedes Fuller stated that he was an educator in support of the request and that students should learn more about local heroes. Anthony Edwards expressed his support and asked that the City Council honor Mel Waiters who was an icon for San Antonio.

Councilmember Shaw commended Brittany and Courtney Waiters for their efforts and noted that the process had been followed. He stated that they had overcome many challenges and he was pleased to support the renaming.

Councilmember Viagran re-entered the meeting at this time.

Councilmember Pelaez expressed his support for the renaming. Councilmember Courage noted that they were able to get a great amount of support from the community so he would support the renaming.

Mayor Nirenberg stated that he had an opportunity to meet and work with Mel Waiters in the past and he was an honorable man of great talent.

Councilmember Shaw moved to adopt the Ordinance for Item 14. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

### 23. City Manager's Report

#### **MIKE FRISBIE- APWA TOP TEN PUBLIC WORKS LEADERS**

Mrs. Sculley reported that the American Public Works Association had named Mike Frisbie, TCI Director and City Engineer, a Top 10 Public Works Leader for 2018. She stated that Mike had 30 years of leadership experience working for three different cities and in the private sector. She highlighted his many accomplishments since being hired by the City of San Antonio in 2007 and had proven to be a strong and respected leader. She recognized Jill Marilley, President-Elect of the American Public Works Association who traveled from Seattle, Washington to help celebrate the achievement. Mr. Frisbie thanked the City Council and Mrs. Sculley for the recognition. He stated that it was a team effort and that he was honored to serve the City of San Antonio. He thanked his family and TCI Team for their support. Mayor Nirenberg and the City Council congratulated Mr. Frisbie and thanked him for his service to the City of San Antonio.

#### **CITY MANAGER'S EXCELLENCE AWARD**

Mrs. Sculley reported that on Friday, May 11th, she presented the 3rd Annual City Manager's Excellence Awards. She stated that recipients and their families were invited to an Awards Breakfast as a token of appreciation for their work. She noted that a total of 36 Nominations were received and five were selected: 1) Rebecca Boysen, Senior Management Analyst, Human Services; 2) Dominic Garcia, Operations Supervisor, TCI; 3) Anayanse Garza, Community Health Worker, Metro Health; 4) Andrew Gordon, Education Coordinator, Convention & Sports Facilities; and 5) Michelle Martin, Senior HR Analyst, Human Resources. She thanked them for their commitment to the City's CORE Values.

#### **PRE-K 4 SA ACCREDITATION-NAEYC**

Mrs. Sculley reported that last week, Pre-K 4 SA received the Gold Standard Seal of Approval from the National Association for the Education of Young Children (NAEYC), by earning the Early Learning Program Accreditation. She noted that the NAEYC Accreditation helps Early Childhood Educators develop an understanding and commitment to maintaining high-quality education. She added that Pre-K 4 SA had received NAEYC Accreditation at its North, South, and West Education Centers and the East Center was finalizing its accreditation process.

**BRIEFING ITEM**

24. Briefing by the San Antonio Youth Commission regarding the outcomes of the Youth Commission Summit held on Saturday May, 12. [María Villagómez, Assistant City Manager; Melody Woosley, Director, Human Services]

Abby Nash, Director of Student Success at the P16 Plus Council of Greater Bexar County, stated that she and Jeanne Russell provided support to the City of San Antonio Youth Commission. She mentioned that the Youth Commission was doing great work and introduced the members that were in attendance.

The Youth Commission Members in attendance presented a Power Point regarding their work over the past year and the Youth Summit they hosted.

Mayor Nirenberg and the City Council commended the Youth Commission for their great work and stated that they looked forward to their future recommendations and policy positions.

Teresa Niño thanked the City Council for allowing them update to the Alta Vista Neighborhood Conservation District (Item 25).

David Bogle commended Development Services Staff for their work to assist them with the update to the Alta Vista Neighborhood Conservation District (Item 25).

Melissa Ramirez presented Item Z-4 and stated that staff and the Zoning Commission recommended denial. She reported that of 42 notices mailed; none were returned in favor and one in opposition. She added that the Wheatley Heights Action Group was in support of the request.

Councilmember Shaw asked if staff had heard from the applicant. Mrs. Ramirez replied that she had not.

Councilmember Shaw moved to deny Item Z-4. Councilmember Treviño seconded the motion. The motion to deny prevailed by the following vote:

Melissa Ramirez presented Item Z-6 and stated that staff and the Zoning Commission recommended approval. She reported that of 67 notices mailed; four were returned in favor and five in opposition. She noted that the Pecan Valley and Highland Hills Neighborhood Associations were opposed to the request.

Mayor Pro Tem Gonzales called upon the citizens registered to speak.

Charles M. Bartlett stated that he was a business owner and member of the neighborhood for 43 years. He expressed opposition to the request noting concern with flooding issues and showed photos of previous flooding that had occurred.

Antoinette Moorhouse spoke in opposition to the request noting that the proposed development was too intense for the Salado Creek Floodplain Area.

David Torres spoke in opposition to the rezoning noting concerns that the Valor Club was not an organization in good standing.

Shelly Chance spoke in opposition to the request. She submitted a copy of a letter from Tommy Adkisson to Councilmember Viagran asking that she consider the Pecan Valley Neighborhood Association's alternative to the redevelopment plans.

Kim Schroeder stated that her family had lived in the area for many years and were opposed to the request. She read a letter from State Representative Roland Gutierrez opposing the

development in the community.

Ruth Medellin spoke in opposition to the request noting flooding issues in the area.

David Morales stated that he had lived in the neighborhood for 30 years and was opposed to the request. He noted concerns with increased traffic and restrictive covenants.

Patricia Del Rio read a letter from Steven Escobedo, Marine Corps Veteran, noting concerns with the Valor Club. She also read a letter from Former District 3 Councilmember Jennifer Ramos asking the City Council to engage with the community and invite their participation in the process.

Tony Torres stated that he was a 32-Year Retired Army Veteran in support of the request. He spoke of the assistance the Valor Club had offered to him and would offer to other Veterans in need.

David Dougherty stated that he was a Retired Command Sergeant Major from the US Army in support of the request.

James Gordon, Retired Army Sergeant, spoke in support of the request noting that the Valor Club had been very helpful to Veterans.

Kevin Crawford stated that he was in support of the request noting the benefits of the development.

George Block stated that this was his 7th year working on the project and spoke of the benefits. He noted the great services provided to support Veterans.

Councilmember Viagran thanked everyone that worked on the project. She stated that the property owners and residents were not able to reach an amicable compromise but felt this was an opportunity to shape the future and create prospects for economic development. She noted that she would hold the property owners accountable on the stipulations set forth and confirmed that it was owned by the San Antonio Housing Trust. James Griffin, Applicant, submitted an amended site plan and confirmed that there will be no vehicular connection to Pecan Grove except for emergency vehicles and that residential units will not exceed 1,400 units. Councilmember Viagran stated that they were working to finalize deed restrictions and confirmed they would be finalized before any building permits were pulled for the rezoned property. Mr. Griffin indicated that they would be working to finalize them. Councilmember Viagran added that the development would be unique and meet the needs of the military community.



Councilmember Sandoval thanked everyone for their work and asked of the drainage issues. Jacob Powell stated that their drainage and floodplain requirements were the same regardless of the number of units. However, staff did not have enough information at this point and would be able to make a better determination once building permits were requested. Michael Shannon added that there were many steps that must be followed before construction could begin.

Councilmember Brockhouse stated that he was pleased that they would be downzoning the property. He added that he would like for the Valor Club to work with the residents of the area to ensure safety measures and protections are in place.

Councilmember Viagran moved to approve Item Z-6 with the amended site plan. Councilmember Shaw seconded the motion. The motion to approve prevailed by the following vote:
