

AN ORDINANCE 2015-04-09-0288

ALLOCATIONG \$32,000.00 IN TEXAS COMMISSION ON THE ARTS FUNDS TO AND AUTHORIZING CONTRACTS WITH ANNA DE LUNA, JIM MENDIOLA, ELIJAH RIOS, UNIVERSAL STYLE SCHOOL AND FABIOLA OCHOA TORRALBA.

WHEREAS, the Department for Culture and Creative Development (“DCCD”) applies annually to the Texas Commission on the Arts (“TCA”) for funding that helps leverage the City’s local arts investment and through this process, DCCD was awarded \$32,000.00 to support local non-profit arts and cultural organizations; and

WHEREAS, in the second year of a two-year funding cycle, TCA awarded the City of San Antonio \$32,000.00 to re-grant to local non-profit arts organizations for arts and cultural projects and DCCD conducted a stART Place application process to award such funds as one-year grants to arts organizations, neighborhood associations, and local artists/artists collectives to support creative projects that provide meaningful community enrichment and neighborhood transformation; and

WHEREAS, the Cultural Arts Board approved preliminary and final funding recommendations on March 30, 2015, which recommendations are reflected in Section 2, below; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. A total of \$32,000.00 in TCA funds are awarded to the applicants listed in Section 2 in the amounts indicated. The terms and conditions of the template Arts Agency Contract for stART Place projects were approved as part of the 2015 Budget and the City Manager, or her designee, is authorized to execute similar agreements with the agencies receiving such funding.

SECTION 2. The sum of \$32,000.00 is appropriated in fund 2600528010, internal order 128000000022. Payment is authorized to the following five applicants:


SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.


