AN ORDINANCE 2016-12-15-1000

AUTHORIZING THE SETTLEMENT OF A LAWSUIT STYLED ROGELIO GALVAN, ET AL. v. CITY OF SAN ANTONIO, CAUSE NUMBER 2014-CI-18935, PENDING IN THE 407th JUDICIAL DISTRICT COURTBEXAR COUNTY, TEXAS, FOR PAYMENT IN THE AMOUNT OF \$190,000.00.

WHEREAS, Plaintiff Rogelio Galvan and Norma Galvan are seeking damages as a result of an accident that occurred on July 2, 2014 at the intersection of Lark St. and 36th St., in San Antonio, involving a City vehicle and vehicle operated by Rogelio Galvan.

WHEREAS, it is in the City's best interest to settle this matter to avoid the uncertainty and risks associated with further litigation; and

WHEREAS, the parties have reached a mutual agreement to settle all claims for the amount of \$190,000.00 payable from the Self-Insurance Liability Fund subject to City Council approval; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The amount of \$190,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund, General Ledger 5402530 General Liability Claims, Cost Center 7509020001 Risk Management-Liability, and is authorized to be made payable as follows: \$190,000.00 will be paid to plaintiff Rogelio Galvan and Norma Galvan and their attorney KRW Lawyers as settlement of Cause No. 2014-CI-18935 styled *Rogelio Galvan*, et al. v. City of San Antonio.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
