

ORDINANCE

AUTHORIZING THE ACCEPTANCE OF FUNDS FOR AN AMENDMENT TO AN EXISTING FY 2020 FAA AIP GRANT FOR THE AIRFIELD IMPROVEMENTS - PACKAGE 6 PROJECT, WITH THE CITY'S SHARE TO THE FAA GRANT IN THE AMOUNT OF \$1,041,667.00 AUTOMATICALLY FUNDED BY THE CARES ACT.

WHEREAS, on June 20, 2019, City Council authorized the grant submittal and acceptance of funds for an FAA AIP grant for Airfield Improvements, Package 6; and

WHEREAS, the final grant offer by the FAA was received in December 2019 and City Council awarded the construction contract on January 30, 2020; and

WHEREAS, the City's matching share in the amount of \$1,041,667.00 is eligible for payment through funds received under the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"); **NOW THEREFORE**,


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Aviation Department or designee is authorized to accept funds for an amendment to existing FY 2020 FAA AIP Grant for the Airfield Improvements - Package 6 project. The City's share of the grant, \$1,041,667.00, will be funded by the CARES Act. This action appropriates funds and amends the FY2020-FY2025 Aviation Capital Budget.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


