AN ORDINANCE 2014 - 09 - 18 - 0 6 9 1

RATIFYING THE ADOPTION OF THE FY 2015 BUDGET THAT WILL REQUIRE RAISING MORE REVENUE FROM PROPERTY TAXES THAN IN THE FY 2014 BUDGET.

* * * * *

WHEREAS, the City Council has, on the same date as and prior to its consideration and adoption of this Ordinance, adopted by separate Ordinance the Budget of the City of San Antonio for FY 2015 ("FY 2015 Budget"); and

WHEREAS, the FY 2015 Budget will require raising more revenue from property taxes than in the Budget of the City of San Antonio for FY 2014 ("FY 2014 Budget"); and

WHEREAS, Section 102.007 (c), Texas Local Government Code, provides that the adoption of a budget that will require raising more revenue from property taxes than in the previous year requires a separate vote of the governing body to ratify the property tax increase reflected in the budget, and that such vote is in addition to and separate from the vote to adopt the budget or to set the tax rate; and

WHEREAS, in order to comply with that provision, it is necessary for the City Council to adopt this Ordinance; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. In accordance with the requirements of Section 102.007 (c), Texas Local Government Code, the adoption of the FY 2015 Budget, which will require raising more revenue from property taxes than in the FY 2014 Budget, is hereby ratified by the City Council in all things, thereby ratifying the property tax revenue increase reflected in the FY 2015 Budget.

SECTION 2. A copy of the "Vote Results" sheet for this Ordinance, reflecting the record vote of the City Council on this Ordinance, shall be attached to this Ordinance by the City Clerk, and shall constitute a part of this Ordinance for all purposes.

SECTION 3. There is no financial language required in connection with the adoption of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
