

AN ORDINANCE **2014-12-11-1010**

ACCEPTING THE LOWEST RESPONSIVE QUALIFIED BID FOR THE NORTHAMPTON PARK IMPROVEMENTS PROJECT AND AWARDING A CONSTRUCTION CONTRACT, INCLUDING THREE (3) ADDITIVE ALTERNATES, IN THE AMOUNT OF \$238,913.70, TO MGB GROUP, INC., A 2012-2017 BOND-FUNDED PROJECT, LOCATED IN COUNCIL DISTRICT 2.

* * * * *

WHEREAS, this project provides for parking lot expansion, 400 linear feet of concrete sidewalk along the park entry drive, 1,315 linear feet of new concrete walking trail, solar lights and a solar powered entry gate; and

WHEREAS, this project was advertised for construction bids in September 2014 in the San Antonio Hart Beat, on the City's website, on the Texas Electronic State Business Daily, on TVSA and through the TCI Small Business Office; and

WHEREAS, plans also were available for review by potential bidders at the office of the Terra Design Group located at 816 Camaron, San Antonio, TX 78212; and

WHEREAS, bids for this Project were opened on October 7, 2014 and six (6) bidders responded. Of these, MGB Group, Inc. submitted the lowest responsive bid; and

WHEREAS, this contract will be awarded in compliance with the Small Business Economic Development Advocacy (SBEDA) Program, which requires contracts be reviewed by a Goal Setting Committee to establish a requirement and/or incentive unique to the particular contract in an effort to maximize the amount of small, minority, and women-owned business participation on the contract; and

WHEREAS, the Goal Setting Committee set a 12% Minority/Women Business Enterprise (M/WBE) subcontracting goal; and

WHEREAS, the Economic Development Department approved a partial waiver submitted by the MGB Group, Inc. because the contractor demonstrated a good faith effort to provide subcontracting opportunities for small, minority, and women-owned businesses; and

WHEREAS, this construction contract was developed utilizing the low bid process; therefore, a Discretionary Contracts Disclosure Form is not required; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive qualified bid in the amount of \$238,913.70 from MGB Group, Inc., including three (3) additive alternates, for the Northampton Park Improvements Project is hereby accepted. The contract described herein shall become effective upon the deposit

of all required bonds and insurance certificates so long as such deposits are accomplished within sixty (60) days from the effective date of this ordinance. A copy of the contractor's executed Formal Invitation for Bids and Contract is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. Payment in the amount of \$238,913.70 in SAP Fund 45099000, General Obligation Capital Project, SAP Project Definition 40-00379, Northampton Park, is authorized to be encumbered and made payable to the MGB Group, Inc., for construction services.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
