

A RESOLUTION **2017-02-23-0011R**

IN SUPPORT OF ARTISAN AT POTRANCO MULTI-FAMILY PROJECT APPLICATION TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS FOR COMPETITIVE 9% HOUSING TAX CREDITS.

WHEREAS, Franklin Development Properties, Ltd. has proposed a development for affordable rental housing at approximately North Loop 1604 West, between Military and Potranco Road, to be known as Artisan at Potranco, in the City of San Antonio, Council District 4; and

WHEREAS, Franklin Development Properties, Ltd. has advised that it intends to submit an application to the Texas Department of Housing and Community Affairs (“TDHCA”) for 2017 Competitive 9% Housing Tax Credits for Artisan at Potranco; **NOW, THEREFORE:**

BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO THAT:

SECTION 1. The City, acting through its governing body, hereby confirms that it supports Franklin Development Properties, Ltd.’s 9% tax credit application for Artisan at Potranco, located at approximately North Loop 1604 West, between Military and Potranco Road, San Antonio, Texas 78251, TDHCA #17087, and that this formal action has been taken to put on record the opinion expressed by the City on February 23, 2017.

SECTION 2. For and on behalf of the City Council, the City Clerk is hereby authorized, empowered, and directed to certify this Resolution to the TDHCA.

SECTION 3. This Resolution is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
