OVERVIEW

This report outlines the enforcement activity related to the SAPD enhanced Cite and Release program, which began on July 1, 2019. The period covered by this report is July 1, 2019, through June 30, 2020. This program authorizes SAPD Officers to issue citations in lieu of custodial arrest in certain Class A or B misdemeanor offenses codified within Texas Code of Criminal Procedure Article 14.06 (c) and (d). The SAPD amended existing departmental policy and expanded officer discretion to support the enhanced cite and release opportunities. However, in consultation with the Bexar County District Attorney's Office, the Class A and B misdemeanor offense of Penal Code 28.08 Graffiti was excluded from the authority to cite and release. The offenses authorized for cite and release under the enhanced SAPD program are as follows:

1. Class B Possession of Marijuana (0-2 oz.)
2. Class A Possession of Marijuana (2-4 oz.)
3. Class B Possession of Substance in Penalty Group 2-A (0-2 oz.)
E.g. Synthetic cannabinoids
4. Class A Possession of Substance in Penalty Group 2-A (2-4 oz.)
E.g. Synthetic cannabinoids
5. Class B Criminal Mischief (\$100 or over and less than \$750)
E.g. damaged property, broken windows, flattened tires
6. Class B Theft from businesses (\$100 or over and less than \$750)
E.g. shoplifting, retail theft
7. Class B Theft of Service (\$100 or over and less than \$750)
E.g. non-payment of tab or check, rental fee
8. Class B Contraband in a Correctional Facility
E.g. alcohol, controlled substance, deadly weapon, tobacco products
9. Driving While License Invalid

In an effort to evaluate the effectiveness of the implementation of the enhanced Cite and Release Program and to provide the community with information on the program, the Department will produce a quarterly report providing information on the following:

1. Enforcement Activity
2. Race/Ethnicity
3. Age
4. Gender
5. Location
6. Offense Type
7. Arrest Reason
8. Officer Availability

1. ENFORCEMENT

During the period of April through June 2020 (Q4), the SAPD arrested 1,441 individuals for eligible offenses. Of these, 913 (63%) were custodial arrest, 506 (35%) were issued a misdemeanor citation, and 22 (2%) were released for another reason.

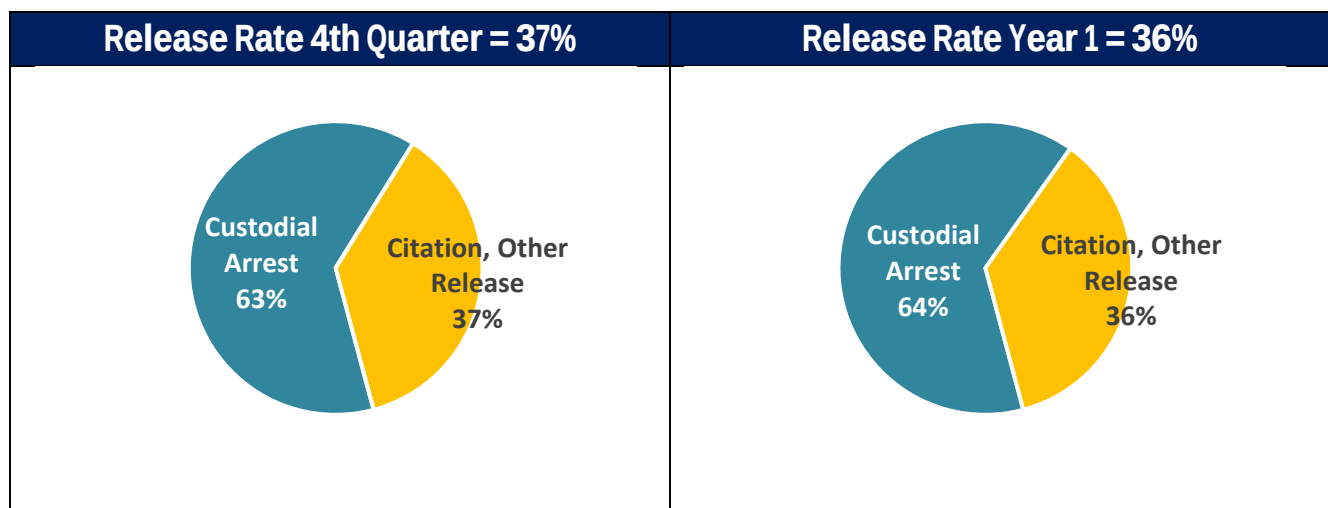
Figure 1.1 identifies the one-year total enforcement activity by type of arrest (July 1, 2019 to June 30, 2020). During the year, the SAPD performed 4,143 custodial arrests which represents approximately 64% of the enforcement activity for eligible offenses. Similarly, the SAPD released 2,304 individuals via misdemeanor citation and 72 individuals via other forms of release during the first year. The year breakdown is consistent with the Q4 results during which 63% of individuals were arrested, 35% were issued a citation and 2% were released for another reason. Other forms of release include: medical, emergency detention and public intoxication.

2. RACE/ETHNICITY

This Section of the report provides information by Race/Ethnicity. Table 2.1 identifies the percentage of arrestees (arrests and citations) by race or ethnicity during Q4 and the total for the first year of the program. During Q4, Hispanic arrests comprised 68% of the total and they make up 69% for the year. Whites accounted for 14% of the arrests in Q4 and 15% for the year. African Americans represented 17% of the total arrests in Q4 and 16% for the first year of the program.

Table 2.2 identifies the number of arrestees either arrested via custodial arrest or released by race/ethnicity during Q4. With respect to Hispanic arrestees, 361 of the 625 individuals were released which represents an approximate 37% release rate. The data related to White arrestees demonstrates 82 individuals were released out of 206 total arrestees or approximately 40%. In Q4, 80 African Americans were released out of 238 arrestees representing close to 34%.

The data suggests there is not a large disparity by race or ethnicity with respect to the outcome of release as opposed to custodial arrest. Additionally, the Q4 data is consistent with the release rate in previous quarterly reports.

3. AGE

Table 3.1 identifies the Q4 arrestees with respect to the age of the arrestee. This data demonstrates that approximately 1,171 or 81% of the 1,441 total arrestees were 40 years of age or younger while the annual percentage is 83% of arrestees who were 40 years of age or younger. This trend is in line with other general crime trends where those engaged in crime tend to be younger as opposed to older.

4. GENDER

Figure 4.1 identifies the number of arrestees based on gender. The data demonstrates that in Q4 75% of the arrestees were male. Additionally, the release rate by gender is provided at 44% for female arrestees which is similar with the 41% annual female release rate. The release rate for male arrestees is 34% which is also consistent with the annual release for males of 35%.

Figure 4.1 – Gender Comparison 4th Quarter

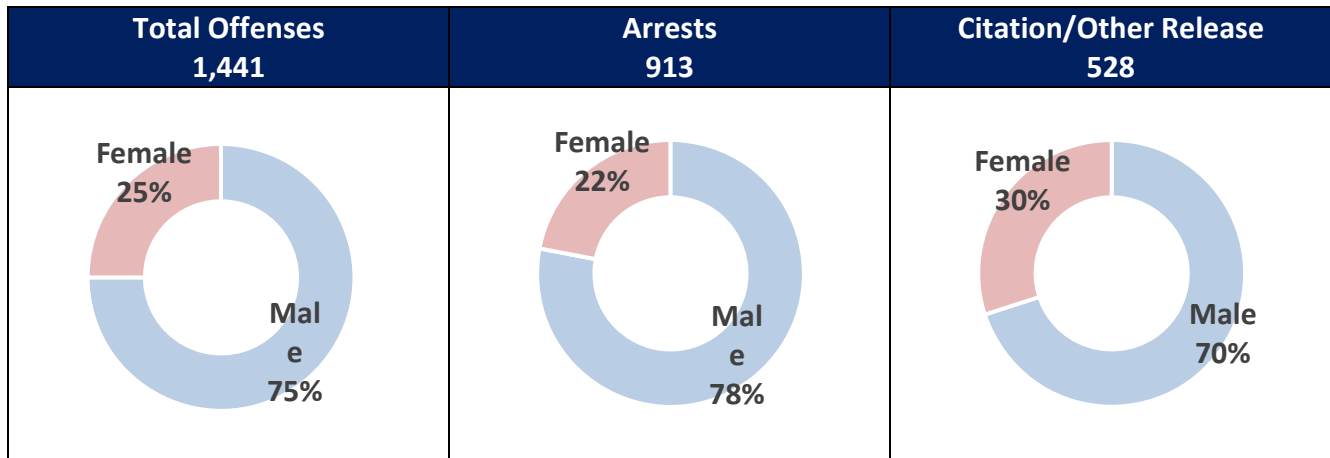

Figure 4.2 – Gender Comparison – Year 1 of Program

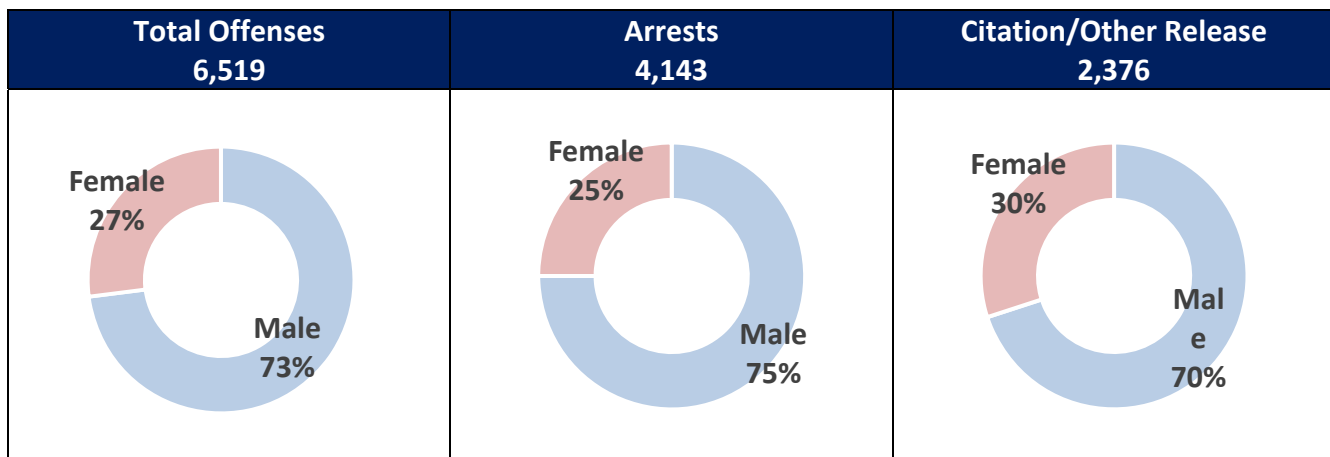

5. LOCATION

Table 5.1 identifies enforcement activity by location within the applicable SAPD Service Area. The number of arrests (custodial and citation release) range from a low of 140 arrests in the Prue Service Area to a high of 313 arrests in the Central Service Area. The SAPD Service Area with the lowest citation rate was the Central Service Area at 32% and the highest release rate was 47% in the Prue Service Area.

6. OFFENSE TYPE

Table 6.1 identifies the enforcement activity by offense and the associated release rate via citation. Class B Theft and Class B Possession of Marijuana are the offenses that generate most of the enforcement activity at 83% of the arrests combined. Class B Theft has a higher citation release rate at approximately 57% as compared to the release rate of approximately 35% for Possession of Marijuana 0-2 oz. The lowest citation release rate is Class B Criminal Mischief at approximately 10%.

7. CUSTODIAL ARREST REASON

The reason officers effect a custodial arrest can vary widely and current SAPD policy identifies certain circumstances where a custodial arrest is required. Figure 7.1 identifies the reason for officers effecting a custodial arrest. The majority of the instances where a custodial arrest was made was due to the individual either being charged with violation(s) beyond the offenses eligible for cite and release and the arrestee having an existing arrest warrant at approximately 83.5% combined which represents a 5.1% decrease from previous quarters when those categories accounted for 88.6% of custodial arrests. In both of these circumstances a custodial arrest is likely required by current SAPD policy as the additional charge and/or warrant require the custodial arrest.

8. OFFICER AVAILABILITY

Table 8.1 identifies the crimes with the highest citation rate and the associated average time savings as compared to custodial arrest times for those crimes. The total reduction in time spent on these crimes was 939.2 hours during the three months. Based on full-time equivalent (FTE) analysis, this reduction results in officer time on call savings equivalent to 2.3 FTE during the three-month period which is slightly less than the savings realized in Q3 which equaled 2.7 FTE. Since the implementation of the program there has been a total average FTE savings of 2.6 officers.

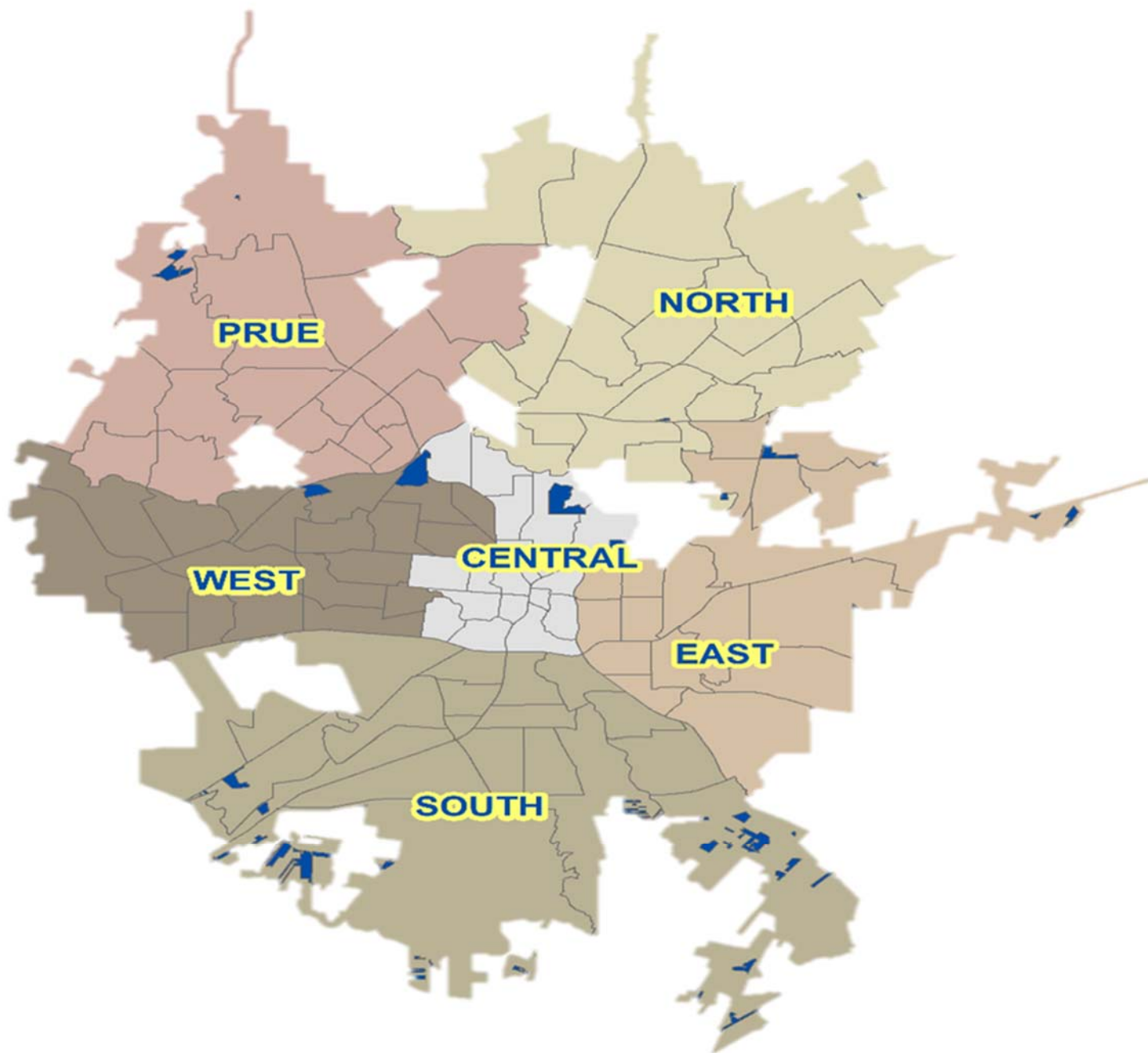

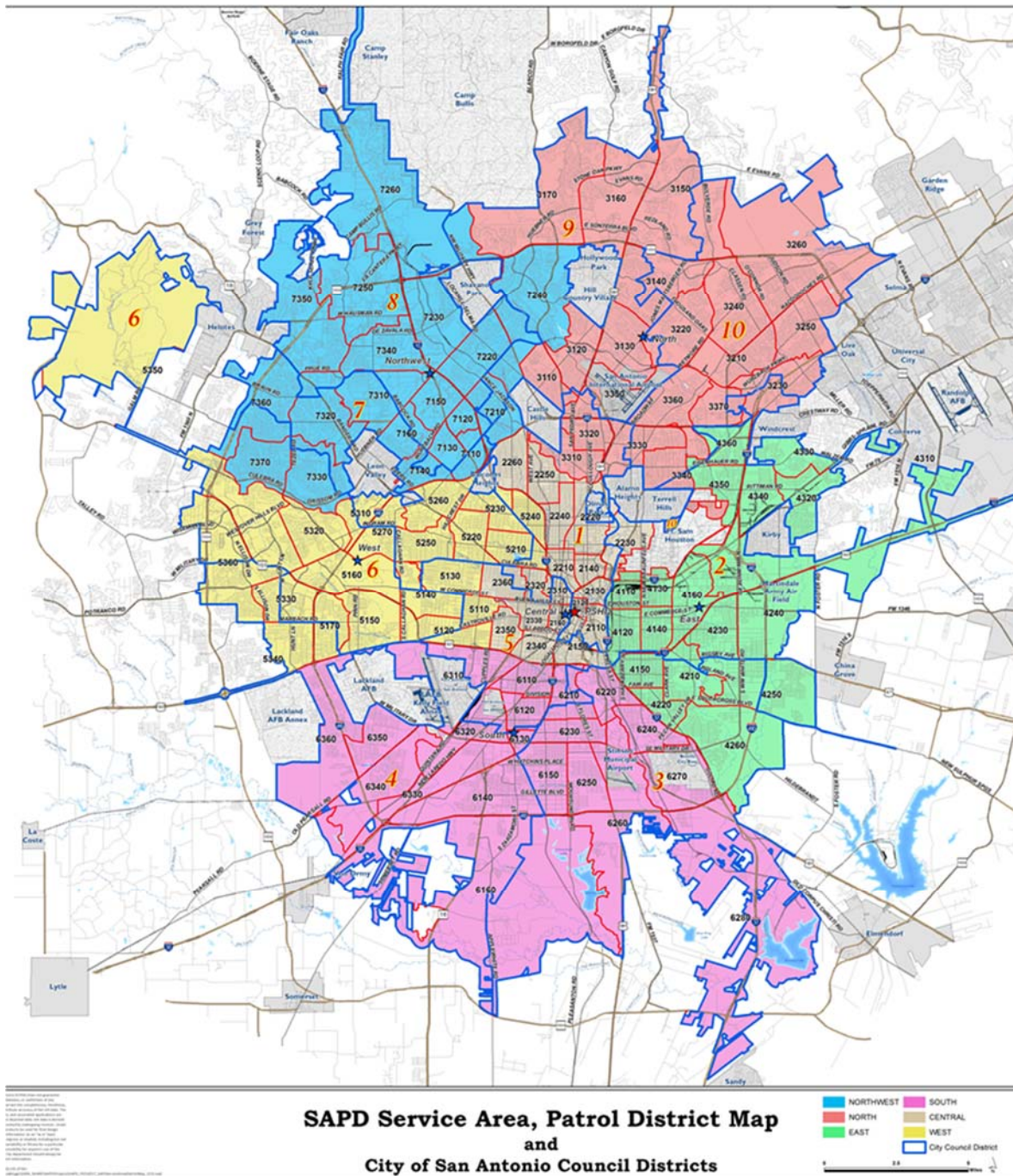
