AN ORDINANCE

AUTHORIZING A CONTRACT WITH 360 TRAINING.COM, INC. TO PROVIDE AN ONLINE FOOD HANDLER/FOOD MANAGER CERTIFICATION PROGRAM FOR THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT.

WHEREAS, the City of San Antonio City Code Chapter 13, "Food and Food Handlers" requires all food establishments that meet certain requirement set out in the ordinance to have all personnel who perform open handling of foods to be certified food handlers within a two month period of employment; and

WHEREAS, the City estimates that approximately 50,000 persons will need training and certification services as a result of this requirement; and

WHEREAS, 360 Training.com, Inc., the current service vendor, has been successfully providing these required service trainings and will continue said services under the authorization of a new agreement; and

WHEREAS, these services facilitate the issuance of food handler and food manager certificates at no additional cost to the City; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee or the Director of the San Antonio Metropolitan Health District or his designee is authorized to execute a contract with 360 Training.com, Inc. to provide an online food handler/food manager certification program for the San Antonio Metropolitan Health District. A copy of the contract, in substantially final form, is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. Funds generated by this ordinance will be deposited into Fund 11001000, Internal Order 236000000012 and General Ledger 4407205.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
