## AN ORDINANCE

AUTHORIZING A PROFESSIONAL SERVICES AGREEMENT WITH PMI STAFFING SERVICES, LLC TO PROVIDE SKILLED STAFFING FOR THE AUDIO VISUAL NEEDS OF THE ALAMODOME, ON AN ASNEEDED BASIS, FOR A THREE YEAR PERIOD, WITH ONE ADDITIONAL TWO-YEAR EXTENSION, FOR AN ESTIMATED AMOUNT OF \$150,000.00 ANNUALLY.

**WHEREAS**, the Alamodome is a 65,000-seat multi-purpose facility that hosts conventions, concerts, shows such as Monster Jam and Disney on Ice, and sporting events such as the University of San Antonio Roadrunners football games, the Annual Alamo Bowl Football Game, as well as the NCAA Final Four Basketball Championship (to be hosted in March 2018); and

WHEREAS, audio visual supplemental labor, in addition to the Alamodome full-time staff, is necessary to handle the high technical demand of hosting these events and the Alamodome recently invested its internal audio visual system to enhance the guest experience, requiring highly skilled workers to operate and protect the City's exclusive audio and video equipment; and

WHEREAS, the number of workers needed varies considerably based on the size and complexity of the event and proceeds received from clients for each event will cover the cost for the audio visual supplemental labor and will have no effect to the City's operating budget; and

**WHEREAS**, the City released a Request for Proposals ("RFP") for Audio Visual Technical Assistance Services for the Alamodome on September 6, 2017 and PMI Staffing Services, LLC, the only respondent, meets the requirements of the RFP and selection committee recommends PMI Staffing Services, LLC; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The terms and conditions of a Professional Services Agreement with PMI Staffing Services, LLC, to provide supplemental audio visual services at the Alamodome, are authorized and approved. The City Manager, or her designee, is authorized to execute the Agreement. A copy of the Agreement, previously executed by PMI Staffing Services, LLC, is attached to this Ordinance as **Exhibit I**.

**SECTION 2.** The costs for this Agreement shall be paid out of event proceeds from Alamodome Liability Fund Number 69017001.
