AN ORDINANCE

AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$536,000.00: (A) BULLCHASE, INC., PATHMARK TRAFFIC PRODUCTS, ROSEN & ROSEN INDUSTRIES, INC. DBA R&R INDUSTRIES, SAF-T-GLOVE, INC., AND SAFEWARE, INC. FOR SAFETY EQUIPMENT (B) DENTAL HEALTH PRODUCTS, INC. FOR DENTAL SUPPLIES, AND (C) NARDIS PUBLIC SAFETY FOR PUBLIC SAFETY UNIFORMS AND ACCESSORIES.

WHEREAS, the City is able to obtain significant savings by purchasing various materials and services on an annual contract basis; and

WHEREAS, these bids are from the following companies to furnish the City with: (A) Bullchase, Inc., Pathmark Traffic Products, Rosen & Rosen Industries, Inc. d/b/a R&R Industries, Saf-T-Glove, Inc. and Safeware, Inc. for safety equipment, (B) Dental Health Products, Inc. for dental supplies, and (C) Nardis Public Safety for public safety uniforms and accessories; and

WHEREAS, this ordinance approves six contracts awarded to the lowest responsive and responsible bidders, and one contract procured utilizing cooperative purchasing; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bids of the following companies to furnish the City with: (A) Bullchase, Inc., Pathmark Traffic Products, Rosen & Rosen Industries, Inc. d/b/a R&R Industries, Saf-T-Glove, Inc. and Safeware, Inc. for safety equipment, (B) Dental Health Products, Inc. for dental supplies, and (C) Nardis Public Safety for public safety uniforms and accessories on an annual contract basis as shown on the attached bid tabulation sheets, are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. The amounts will be encumbered upon issuance of various purchase orders, and payment is authorized to the vendors identified herein. All current fiscal year expenditures will be in accordance with the Fiscal Year 2016 budget approved by City Council, and future fiscal year expenditures are contingent upon future City council budget approvals.

SECTION 3. It has been found and declared that the following low bids for safety equipment failed to meet the City’s specifications and/or requirements: Bullchase, Inc. for Category A, Items 4A – 4E and 5A-5H, Rosen & Rosen Industries, Inc. for Category A, Item 4A, Wenzel, Wenzel & Associates, Inc. for Category B, Items 1-2, 5-7, and 10-12.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
