AN ORDINANCE

APPROVING A NON-EXCLUSIVE 10-YEAR LICENSE AGREEMENT GRANTING EZ BEL CONSTRUCTION, LLC THE USE AND OCCUPANCY OF THE RIGHT-OF-WAY AT A LOCATION NORTHWEST OF THE INTERSECTION OF RECOLETA ROAD AND JACKSON KELLER ROAD FOR THE PURPOSE OF INSTALLING AND MAINTAINING FIBER OPTIC CABLE FACILITIES TO PROVIDE TELECOMMUNICATIONS SERVICE FOR ITS BUSINESS OFFICES.

WHEREAS, EZ Bel Construction, LLC (“EZ Bel”) desires the use of certain right-of-way within the City of San Antonio for the purpose of installing and maintaining fiber optic cable facilities to provide telecommunications service to its business offices; and

WHEREAS, the proposed fiber optic cable facilities will cross under the City’s right-of-way to provide telecommunications connectivity at the location as depicted within the Licensee Agreement attached as **Exhibit A**;

WHEREAS, the installation, maintenance, and repair of fiber optic cable facilities over or under the public right-of-way will be done in a manner consistent with all City of San Antonio regulations, including the Right-of-Way Management Ordinance and Utility Excavation Criteria Manual; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The License Agreement between the City of San Antonio and EZ Bel is hereby approved in substantially the same form as it appears in **EXHIBIT A**.

SECTION 2. The City Manager or her designee is hereby authorized to execute the License Agreement and any and all documents necessary to fulfill the purpose and intent of this Ordinance.

SECTION 3. Funds generated by this Ordinance will be deposited as per the table below:

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific Cost Centers,

WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance becomes effective immediately upon the receipt of eight affirmative votes, or in the event eight affirmative votes are not received, on the tenth day after passage by majority vote.
